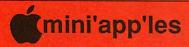

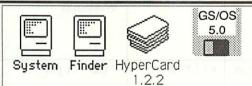

BBS BLUES

At the recent Mac User meeting, there were a few comments raised about the BBS that the Club maintains for its registered members. Hopefully, an erratic, but more persistent "noise" problem has been cured with the repair of the "trunk" line that serves the location that houses the BBS equipment. There certainly are a lot of folks watching the situation, and even a whisper of noise is going to be discussed and bantered about with a ton of creative ribbing.

Another problem expressed by several Mac Users (and I will presume that it also affects Apple II Users, too!) is that of sign-on problems; they think that the computer is not recognizing their membership number. After CONNECTing with the modem, Sysop *Dick Peterson* has a "NEW" caller go through a short sign-on routine to gain access. Once you are "recognized" as a current Club member, you have a much greater system available to you than is presented to casual non-member "browsers" who may be investigating the system on their own.

Dick reminds me that the files he uses for validation are those of the Club's membership roster. As with most computer-programmed routines, the sign-on process is looking for and EXACT match between your on-line answers and the data stored in your record of the Membership files, not just

"something close." The best way to sign-on is to have a your copy of the newsletter at your side and answer the sign-on questions (as many as possible) by copying DIRECTLY from what appears on your mailing label. That even means repeating a typo error (heaven forbid!) if that has somehow been made in your mailing record.

More likely, it will mean using your name EXACTLY as it appears on the label, rather than using the name that you feel like using that day. If you generally sign as "Thomas W. Edwards" (What? There's another around??), but happened to apply for membership as "Tom Edwards," then your mailing label will read "Tom Edwards" and that must be what you use to sign-on. If someone missed the "." after your middle initial in transferring your application to the roster file, and it doesn't show on your mailing label, then don't add a "." after your middle initial as you sign-on.

Finicky, isn't it?

For those of you that are new members and have not received a newsletter yet (goodness! How can you be reading THIS?), please have patience. We are trying to keep the "lag" between when you sign up as a member and when you show up on the roster to just as short of a time period as possible. On the other hand, if you hit the cycle "just wrong," the lag could be almost two months. If you feel that you have slipped 'twixt the cracks somehow, please write to the Membership Coordinator at the Club's Hopkins PO Box number and ask that a check of records be made. Give all the information you can about when, where, etc. you filled out the application and how it was turned over to the Club.

We want you as a member... a satisfied member... and will try to fix any slip-ups. However, in the case of BBS sign-on, you'll have to remember that close doesn't count, like it may in horseshoes. You have to throw a ringer right on!

The AppleWorks Advisor

A Column For Users Of AppleWorks

AppleWorks 3.0 Shipping

During the last week of August, I began getting calls from AW users reporting that they have received their program update to AW 3.0. The first call I got was from Bill K——. He generously offered to let me examine his AW update package, since mine had not arrived. Due to his thoughtfulness. I tested and can and write about AW 3.0 now.

An interesting aside is that I ordered my upgrade during the last week of June using an order form published in the July issue of the A2-Central newsletter. Bill phoned his order to Claris in August. His upgrade arrived, mine has not shown up yet and it is now after Labor Day.

The First Look

When booted on a computer which has enough memory, the first addition noted is the addition of "thermometers" to show the progress of activities in process. This is useful for tracking how much has been done and as an indicator that some activity is occurring.

If enough memory is available, the entire program loads to memory on bootup. This preload process is fast. Apple (slinky), Applied Engineering and Checkmate (bank switch) and Apple GS memory boards are automatically recognized by this version of AppleWorks. Program module preloading requires the computer system have a minimum of 320K of RAM. As the new program is more powerful and larger, the desktop on a 128K computer is reduced from 56K to 40K.

Memory Recognition Problem

A user reported to me that AW 3.0 did not recognize the bank switch memory on the SuperExpander make of memory expansion board. I contacted the distributor of this product to inform him.

RAM Disk Use

An information sheet from Claris, titled "Apple-Works Release Notes," is packed with the upgrade. This sheet advises users of RAM disks that updates to the RAM disk utility software will be necessary. Users are directed to contact the manufacturer of their memory board for this.

I called Checkmate about this and was informed that they will have a patch for RAM disk users in "about a month." This will be necessary to prevent AppleWorks from double loading when installed

in RAM. While I had them on the phone, I inquired about the status of their long overdue utility software update for AppleWorks version 2.1. The reply was not very hopeful.

Sometimes I throw roses at manufacturers of computer products, when products are outstanding or support warrants recognition. Earlier, Checkmate Technology has been the recipient of roses. However, in this single instance, I am nominating them for the "Steaming Cow Pat" award for their conspicuous failure to support users of their Apple // memory products with the utility software upgrade for AW 2.1.

Program Highlights

This major upgrade to AppleWorks has a lot about it to like. The power has been increased with larger capacities and more functions. Many areas of the program have been improved.

AW 3.0 now includes a spelling checker. Although not identified as such, it is a beefed up version of QuickSpell. Because Beagle Bros was involved in the development of AW 3.0, there are some Beagle TimeOut functions built-in, plus small Beagle touches scattered through. TimeOut QuickSpell is a notable major addition. Beagle added this best selling of the TimeOut programs to AppleWorks. The QuickSpell program file and the Main Dictionary have been incorporated into a single large file.

The speller module does not auto-load to memory. It appears a RAM disk will have to be used to have the speller memory based. This spelling checker can be configured to provide a word list where words can be marked to ignore, replace, add to dictionary or for correction in context. The speller can also be configured to go to in context correction directly, bypassing the error list. It can be set to produce a summary of errors without immediate correction. I detect the hand of school teachers in this option.

ProDOS Directory Feature

The add files to the desktop options have been changed to include a point and shoot function to setup ProDOS pathnames. This function allows users to select a pathname from successive menus, a step at a time. This is like a set of training wheels

on a bike. It allows the user to access files with pathnames without knowing what the pathname is. Slow but effective.

For awhile, it appeared that the training wheels had been welded on. I did not find any reference in the software manual to a method for typing a pathname in directly. Someone tipped me that an OA-RETURN when the cursor is placed on ProDOS directory, will allow a pathname to be typed. This option lets knowledgeable users enter pathnames directly without the point, step, point, step repetition. Macro commands which include pathnames should work with slight modification.

The issue here is "ease of use" versus power. Entering a ProDOS pathname by typing it is the powerful thing to do. ProDOS will find the desired pathname in any ProDOS storage device, despite where it is. It gets to the heart of the onion by cutting through all the layers. The menu prompted method works by pealing the onion down one layer at a time.

In my case, I have 7 ProDOS storage Volumes available all the time. For me, the menu-method of arriving at the point where I can select and load a file would be useful only for disks where the contents are completely unknown to me.

Beagle TimeOut And AW 3.0

TimeOut products will be modified to work with AW 3.0. Beagle Bros has not sent me (and other Beagle Buddys) any updates yet. I expect they will soon, but please be a little patient and wait for this to happen.

Printers

AW 3.0 will support up to 3 printers at once. All of these can be Custom printers if desired. I hoped that the new feature of the printer drivers which allows the user to define 6 commands would solve a printer feature utilization problem for me. I have not been able to get my C.Itoh ProWriter C310 printer to output proportional printing with Apple-Works. The custom printer does not support this feature. I have tried many tricks and techniques, but Apple-Works always prevails and defeats this print mode.

I quickly setup a Custom driver for the C310 and defined a command to turn on proportional printing. Alas, it did not work. In one extended test session, the text selected for proportional print was printed at 12 CPI normal instead. A printer hex dump (printer feature which prints the codes being sent instead of text) showed that the proper code for proportional printing was being sent, but it still did not work.

Other printer features worked when entered as Special Codes selections. Italics works fine. Unlike printer features which can be entered with Control codes, the Special Codes must be accessed through the print menu. No matter, it can be setup with a macro command.

Apple //+ — Dead or Alive

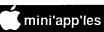

Spelling Checkers

Ever vigilant in my quest for new computer words to increase my high-tech vocabulary, I called a Bulletin Board System (BBS) in some remote town. The name of the town is unknown to me but the BBS is well known to the hackers in the underground. I am under the threat of a strong magnet being delivered to my computer room which will destroy every disk I have if I give out the phone number. I can't do it.

I was going to contact my source for new computer words from the computer industry, the hackers and the magazine publishers. (This source is not to be confused with "The Source" in the Bloomington area).

Author's Note Below - Spelling checkers will contain most of the words found in a dictionary. However, the word, Socio-Psychologico-Politico-Militarico, will not. The word is listed in the Army's publication - Manual, Army, OK Words, One Each, Serial Number 17689-A45-2, Chapter 14, Sub-section 12-G, Paragraph 6, Line item 5D. It's classified TOP SECRET. That's it...

COMMAND.COM

Apple II Software Review

COMMAND.COM is a new program from HyperDyne Software and Pinpoint Publishing. It is a collection of utilities, programs, or commands designed to emulate the MS-DOS operating system on Apple II's. While COMMAND.COM looks like MS-DOS, it does run under ProDOS. COMMAND.COM allows you to create 'environments' that act like ProDOS or even Unix.

Many of the commands are internal; the rest are external, to be loaded from disk as needed. The external commands may be renamed to suit your tastes and users may write their own. It is also compatible with Pinpoint's Desktop Accessories. The flexibility allows one to "mix and match" to achieve almost any objective.

What does it do?

You can use its command line interface to perform most disk utilities. These include copying files, formatting disks, comparing files, and so on. "Big deal," you say. After all, all of us have some form of disk utilities, even if it is only ProDOS Filer. And most of them try to shield us from having to type subdirectory and file names. What sets this program apart is its combination of simplicity and flexibility.

Suppose you have AppleWorks stored in a subdirectory of that name. To copy it to a Ramdisk, all you need do is type: Copy AppleWorksR:. What could be easier? In addition, wildcards are permitted. And you may use optional 'switches'. Examples include: -D to prevent overwriting an existing file, -P for a prompt for confirmation, and -Q to turn off the display while copying. Many commands may be redirected. For example, a disk catalog may be sent to a text file.

More importantly, al least for me, is batch file capability. You can use their text editor, TED, AppleWorks, or most other word processors to create text files of a list of commands. When the file is invoked, COMMAND.COM will execute them as though they had been typed in from the keyboard.

The batch file commands are somewhat like a programming language. These include: For/Next, If/Then (with a wide variety of conditionals), Getkey for specific responses, Goto, windowing and error checking. What you can do with these is limited only by your ingenuity.

The batch file example in the manual shows a

method for doing client billing for AppleWorks. It asks you for a client's name, creates a text file of that name, writes the time and date to the file, runs AppleWorks, returns to the batch file and writes the new time to the file. The time difference would be the amount of time spent on that client.

How do I use it?

I use COMMAND.COM to control loading and deleting files from a Ramdisk, and to start up certain applications. One in particular is Quicken, a check-writing program from Intuit. A bad habit of Quicken is that it insists on trashing slot 3 Ramdisks. It does inform you that it wants to do this and asks you if it is OK. I cannot imagine it ever being okay, so if the program goes to the trouble of providing a warning message, it should do something to prevent the problem in the first place—but that is another story.

COMMAND.COM to the rescue. My Quicken batch file is started from my program selector. (The system file is IO.System and the program file is the batch file.) It first looks to see if the checking account data exists on /Ram. If not, then it makes sure that the data disk is online and provides a prompt if necessary. Once the data file has been copied to /Ram, the next step is to verify that the Program disk is online. Then Applied Engineering's Slotchanger is run to redirect /Ram. This prevents /Ram from being destroyed and makes it available to Quicken. (Slotchanger has been modified to act like a switch. Each time it runs, it alternates between slots, without intervention.) Ouicken is then started up. On exit, you are returned to the batch file and the /Ram slot is restored by Slotchanger. "Finally" is a prompt for backing up the check data-very straight-forward and fully automatic.

Recommendations

Obviously, I like it. I find it useful, even though I am sure that I have not even begun to exploit its full capabilities. This is one of those programs that you do not hear that much about, but should. The fact anyone can use it to easily customize their operating environment is reason enough to buy it.

STACK BUILDER

"This stack is the result of working with people who can't (or don't want to) try their hands at learning HyperCard™... or even read the manual! They still want to use it however, and come to me with comments like, "If it's so great, why can't it build itself?!" Some Recent Mac SIG Meeting Events by Tom Edwards

(Editor's Note: This month we're fortunate enough to have two reviews of the August DTP SIG meeting. They have been placed side-by-side directly following this article to give you an opportunity to see how different individuals respond to the same meeting.)

The HyperCard SIG...

chaired by *Mike Carlson*, met in a bit tighter quarters at **Hagen Office Equipment** in late August. The training room had been scheduled for an income-producing session on this evening, so we moved into one of the smaller demonstration rooms.

The program had been set to be a demo of an interactive training course being worked on by one of the regular attenders. Good news, bad news; the company he was working for was bought out and moved computer, disk and programmers, down to Arizona the week before our meeting. That left us on our own for a program subject to discuss. Not that you'd hardly notice, for there were a lot of HyperCardian questions raised, and a few even answered!

HyperCard continues to be a difficult program to define. Some relegate it to little more than a note pad. Yet, with the ability to link into video disk and compact disk, it has the capacity to access gigabytes of storage. Two of us acknowledged the database aspect, though on a more modest scale. We're both using it to keep track of upcoming high school reunions. Another (Jeff Cooke) uses it to store items being collected for a forthcoming book.

Departing from the norm a bit, another (*Tom Cleland*) is tracking the layout of his IBM mainframe programming efforts by using HyperCard. And some use it as a custom accounting program. Needless to say, HyperCard can probably be something to most anyone, if you want to give it a try. And the unique thing about it is that many of the folks whodo some sophisticated things with it would tell you that they didn't know the first thing about writing any kind of program code!

A bonus came from a member...

whohad recently tracked down a place to purchase a copy of **Voyager**, a program that is used to track the celestial heavens. Admittedly, this was off of the HyperCard subject, but we all found this to be a thoroughly engrossing program. Sonny Taylor had long been interested in the night sky, and tried to get an understanding of it through reading text books on the subject. With Voyager, all of the obtuse terms, sky grids, constellations and orbit mechanics finally fell together into an understandable unity, rather than scattered theory and terms.

If this subject holds a mysterious interest for you, this might be something that you should look into. The recent lunar eclipse, Halley's comet passage of a couple years ago (and the one in 845 AD, for a real close encounter of the amazing kind!), and dozens of other events are accessible from this database of 14,000 starry objects.

All in all, it turned out to be a very interesting evening, even though the group had to fend for itself to recover from unavailability of a program presenter due to corporate takeovers.

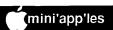
The Mac Users Group...

It is amazing how much utility can be had from programs of this type. Some are very small and devoted to a single purpose (I think SetSound is only about 700 bytes long) and others are sophisticated mini-applications that rival some of the stand-alone programs. You will find freeware, shareware and commercial products available. If you need to get some help with a task, check through the Club eDOMs. There may be just the thing that you need, all ready to go to work for you as a mini-application.

Computer Art and Design Coordinator Joy Kopp arranged for a presentation by Mark Filonowich of Bolger Printing to discuss the hard facts of using the Mac as a tool in the preparation of printed material. Mark talked about the everpresent need to closely monitor what you prepare on your Mac for output by a service bureau's high resolution printers. The Mac screen never seems to be just exactly "what you see is what you get", and when you think about it, that makes sense. The Mac screen paints at 72 dots per inch. Hi-res output ranges from 300 to 2500 dpi... so changes are the norm, not the exception.

You should check with the service bureau that you will be using so that you can coordinate as best as possible to avoid mess ups. Font conflicts are one of the most common problems. There are also problems from the switch in resolution, registration (if there's not much "fudge" to play with), traps, separations (the interjection of 'moires') and color matches.

Bolger (and probably several other printers, too) is very aware of the Mac and the publishing

link. If this is a need you have, you would be wise to search around and find a service close to you that knows how best to make the transfer from floppy to film and willing to work with you for maximum result. There are a lot of changes in the wind, so be prepared to experiment. Your efforts will be rewarded by output that holds true to the ideal that you envisioned.

And that ain't all...

if you are an avid Macintosh user. There's always a Special Interest Group that may hold just the help that you need. Even with the ten or so group meetings a month, you still may find that your special interest is not fully addressed. If so, give me a call. Maybe there are a few others with interests similar to yours, and that's all that it takes to get started with a new SIG!

Just Your Type

Mac DTP SIG August Meeting by Linda L. Bryan

he August Desktop Publishing SIG met at First Tech on Wednesday, August 23, with a much-diminished attendance. All had choice seats, and no one had to sit outside the meeting room or share a chair. Let the members beware: Chuck Bjorgen, our SIG leader, reminded us that the SIG meets on the fourth Thursday of the month, not on the last Thursday of the month.

Those who did attend learned a lot about typography. The speaker was Les Metz, University of Minnesota Department of Printing & Graphics and also an instructor in the University's Journalism Department. He began with an illustrated history of type.

The Evolution of Type

Les showed slides exemplifying historic typefaces, beginning with cuneiform tablets and moving to Greek and Roman work. A slide of the Romans' famous Trajan columns, which I've read about but never seen, was projected onto the screen: the most perfect model for letterforms typographers can refer to. The lettering chiseled on the columns is in a classic balance of proportion and spacing.

Soon, the slides showed fifth century all-capital hands, then sixth century "uncials"—rounded characters with some letters almost lower case—and seventh century "half uncials." Then, ta-da, came the "manuscript" letters of Carolingian script in the eighth century, the forerunners of modern lower case letters.

I found myself looking for hints of familiar typefaces in these slides of old documents, and sure enough, they were there. It's fun to connect what we know with what we're experiencing. Like others in the room, I started jotting notes.

Next came the illuminated documents. These were the scribe-transcribed books of the ninth and tenth centuries with elaborate design and rich color in the oversized letterforms, especially in the initial capitals. Example after example made clear that wrapping text around graphics is an old technique, as are drop caps and one-, two-, and three-column layouts with generous margins.

Les explained how precious these books were, even at the time they were made. These were rich books for the wealthy reader, done by artists who cared so much about the texts that they couldn't just copy them—they had to decorate them.

By the sixteenth century the Gothic, or Fraktur, hand was popular. These angled, elaborate letters were in vogue when Gutenberg created movable type. (Quick—what does "incunabula" mean?)

Modern typefaces date from the seventeenth century onward. Yes, Bodoni and Palatino are not new! There are a number of categories into which modern typefaces fall, and the desktop publisher can master them by observing their similarities. (The Adobe typeface catalog was recommended as a good place to begin to study type, as are the articles on typefaces in Publish! magazine.)

Choosing typefaces

Do we each need to know thousands of typefaces? No, says Les Metz. Instead, get to know a few typefaces well. Look hard at the variations in their constants, especially the lower case e, g, and t. Observe how a typeface functions on a page, like textures playing across a fabric.

"Beautiful letterforms were designed by artists who thought of type as art and sculpture, the rhythmic flow of form and counterform." Paradoxically, though, he also said that "To the average reader, type is the same. This is good—type should be transparent." This means that it should not call attention to itself.

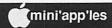
Nevertheless, the user should notice how type is fashioned. It is designed to carry space on either side of itself. The space is just as important as the letterform it surrounds. Les noted that word spacing in a big problem area in desktop publishing. He cautions us not to let the machine spacing go unchallenged. "What looks right is right," since the eye is a better judge of design than is the ruler.

Desktop publishers: The agony and the ecstasy

Les had a lot of other criticisms of desktop published documents. Among them were these:

- Running text around irregular illustrations is difficult to do well.
- · Shadows under text blocks are overused.
- Tint backgrounds are often distracting, especially because many screens are too coarse and their dots conflict with the dots which compose the letters.
- Line length should be approximately one and a half alphabets (about 40 characters); if a line must be longer than that, use leading to open up the space

August Mac DTP SIG Meeting by Tom Edwards

he DeskTop Publishing Group, Chuck Bjorgan Coordinator, met at First Tech Computer for the August meeting. One of the hot subjects for the Q/A session, was the impending font technology that is discussed in "directional" releases by Apple about the yet-to-be-released System 7.0. Messing with fonts has been the bane of DTP'ers, particularly when faced with the need to transport a diligently prepared file to a service bureau for final output by some high-buck piece of equipment. It's those last minute "surprises" that drive the Mac artist nuts, causing a line change that disrupts the layout due to WYSIWYG differences 'twix screen and hardcopy.

The shoot-out between Apple's technology for "outline" fonts (System 7.0) and Adobe (reining king of the outline fonts with PostScript standards) promises to be a real test of sanity for the DTP'er. The old question "Is it better to fight than switch?" will be raised to new levels. Adobe is not sitting still for all of this thunder stealing, either. Their "Adobe Type Manager" seems to be aimed at trying to be compatible with Apple's outline font technology (QuickDraw), while still holding an open window for PostScript. Apple professes to be doing the reciprocal.

You and I know that this is like climbing into a cage with a pit bull and a wildcat and telling them both to 'mind their manners' while you take a nap! If anything moves after the dust settles, it will be a wonder. And if you can tell what it is, if it does move, it will be a miracle!

Other subjects of discussion before jumping into the program included:

- Canvas: Linda Bryan is still wooing this program with a love/hate relationship. She loves the program for what it can do, but hates the manual for what it doesn't tell you, or telling you what it does but in an incomprehensible way. (We may have to come up with an antiaward for the worst manual by a contending program!) Adding RAM, gobs of it, seems to bring an almost universal improvement. It at least has slowed the pace of the mad bomber that roams the hall of this program's code.
- ScrapBook: For the DTP'er, this can be a great help to store frequently needed page layout items. Things like drop caps, standard paragraphs, or oft used logos can be called up

- quickly. If you haven't yet done this, and want to try it out, look for one of the shareware or commercially available improvements to substitute for Apple's ScrapBook DA. Lots more utility can be had than what Apple provides.
- Charts: How to create a chart and then dress-up its labels for a more attractive look? Jim Horswill tried to copy a chart from Excel and paste it into a drawing program to do this and ended up with artifacts that could not be selected and a bit map that would not allow text to be selected and rotated. Don't know what was wrong, but this is exactly how it should be done to allow the fine tuning of a chart for best appearance. (I tried it when I got home and it worked. Hope you had success when you tried it again, Jim.)

The program...

for the evening was Les Metz, of the Printing and Graphics Department at the U of M. Les had a slide show about typography, a subject obviously dear to his heart and one that he is well versed in. Though not a "Mac person," Les captured the attention of the Mac DTP'ers with a history of type examples starting with cuneiform markings of the ancients.

Many of the typefaces in use today are derived from Roman and Greek faces that hit their heyday several hundred years B.C. The "forms" of these letters are often studied just for the art and grace of their shapes, as well as the readability of text written with them. (I guess that when you were committing your works to stone, you didn't want it to be just any old type!) The development of movable type in the 15th century also saw the creation of a number of typefaces that continue to be used today. Talk about durability!

Les gave the group a number of "hints" that he would suggest for the DTP'er. He likened the printed page to a "fabric" that is not viewed as individual threads, but seen as an impression of the whole work, wherein the look is the sum of threads, texture, color and designs. Believing that good typography is "transparent" to the reader, he suggested that more attention be paid to spacing of words and lines, to the selection of typefaces that harmonize with the message, and to the balance of the page. Perhaps the idea that a page should look good, even if one steps back far enough that the

Hyperion Hyperpyrexia

've been moving the last few weeks, finding the extra hours late at night when no one was looking. In June I transferred to a Mac SE/30 (The SpaceStation). In July I suffered a hard disk crash, and to really make me feel abused, it crashed again in early September. I did have backups (cross those fingers), but gee wiz already! The result is that I haven't really had a lot of time for home computing lately, so I'll make this months entry short. My idea this month came to mind while I was playing with old stacks I'd written inbetween crashes. I started getting some weird errors, the kind that sort of work but with strange results. And then suddenly kerflooey, the Mac barfs. To make a short story stay that way, the XCMD sortitems (), found in the Developer's Stack is confused with my SE/30. Plenty of morals here. If you want to develop, you need to be very aware of your software and the changing environments it runs under. And if you simply want that next ziffle blasting x-12 power boosting hardware to wallow in, be prepared for some upgrade surprizes. By the way the Developer's Stack (AnalytX, Box 388, Southampton, PA, 18966) is a nifty disk that comes with a single HyperCard stack loaded to the gills with XCMDs, XFCNs, and scripts for you to use are your leisure. A must for any HyperTalker. contact by Steve Drazga).

Scrolling Lists You Can Select From

Well, the routine that broke was a part of a field list that I had set up. In this field are a bunch of names, which are kept in alphabetical order. The neat thing about this list is that when the mouse is within the field, a user can press a key to scroll to that alphabetical section. In addition, if a user clicks on a name in the list, the name is selected and a script can then do as it pleases with it.

In this discussion I'm going to assume that the list is already in alphabetical order. If you've got something less than a Mac with the 68030 CPU powering it, you can probably use the sortitems () XCMD above. Or you could write a little sort script. I promised myself 2 hours sleep tonight, so you're on your own here.

Lets look at the keyboard scrolling feature first. The key here (I'm really to tired to pun) is another XCMD found in the Developer's Stack called

inkey(). When inkey() is invoked it returns a character typed into the keyboard. It is important to limit when this function is active, because it eats keystrokes. So we'll tie it to the field in which its used. If you plan on using your scrolling field like a pop up menu (i.e. show and hide it), you can invoke inkey() when the field is shown. For my application I wanted the field always available, so I put the inkey() statement inside a on mouseWithin handler. Only when the user places the cursor over the field will inkey() check for key presses. Lets look at the script.

on mouseWithin

Notice that I check for the visibility of the message box. This is a small compromise. If the message box is visible, the user may be trying to type into it even if the cursor is over the field. So I decided that it was more important to service the message box than the field. You may decide that some form of feedback about this situation is warranted. Even more important is the check for the value of lockText. There is nothing more infuriating than trying to type into a field that won't let you!

The function numtochar() converts a character (or letter in this case) into a number using ASCII, a code that maps individual character letters to numbers. Once we have a characters numeric

value, we can compare the character order verses other characters. ASCII charts can be found in most programming books.

Ok, so we got our key from the keyboard, now what? We have to search for field entries sorted on that character. This is done in a script called on getLine inKey.

Basically what this script does is compare the value of the inKey with the first character of the line at the middle of the text field. If the inKey is

less then this character then we can ignore the rest of the text field. If it is more, then we can ignore the first half of the field. Once we know which half to look in, we repeat the process for that remaining half. The script continually divides the remaining text in half until it hits the right character. Then we back up each line until we find the first line sorted by inKey. Here isfunction mid, used by the script.

Last month I remarked that it is good form to put scripts in higher places (e.g. cards, backgrounds, or stacks). I put this one in the field because I was lazy and only needed it there. However, on getLine could easily be moved, to say the background, by replacing the word "me" with the phrase "the target". Look "the target" up in your HyperTalk scripting book (you do have one don't you?) it is a very handy little function. I'll spend some time on it in later articles. If your looking for good HyperTalk programming books may I suggest three that have served me well.

HyperTalk Programming, by Dan Shafer HyperTalk Script Language Guide, by Apple Computer

HyperTalk, by Lon Poole — a concise quick reference

WorksPlus SPELL and WorksPlus COMMAND

orksPlus SPELL and WorksPlus COMMAND are two utilities from Lundeen and Associates (Oakland, CA) that add greatly to the usefulness and power of

Microsoft WORKS. The programs install seamlessly into WORKS, and each can be used alone or in combination. Considering the price of these little beauties, (\$89.95 and \$99.95 respectively, suggested retail, less than \$60 each by mail order) you would be hard-pressed to find a program that has as many features as a combination of the three programs. Tim Lundeen of Lundeen and Associates was one of the programmers who ported WORKS to the Mac environment from Apple-Works, and the programming "hooks" to accommodate COMMAND and SPELL were part of the program from the very beginning.

SPELL is a full-featured speller that is far faster than any other Macintosh speller I have experience with, and includes excellent hyphenation and glossaries for often-used phrases.

COMMAND is a macro program that will let the user record any series of mouse moves or keystrokes, and is also a programming language that will let the more sophisticated user write his (or her) own macros to accomplish the desired result. According to the manual, the language is similar in structure to "C" and "Pascal", although I can't prove it, since I have no experience with languages beyond a very preliminary stab at Hypertalk. Twenty-nine pre-written macros come with COMMAND. These will do such useful things as make an index, a table of contents, assign styles, or even let you specify the size and placement of a graphic element down to the nearest pixel. The macros also serve as examples of what the language will do, and how to accomplish your aims.

SPELL

I have used SPELL for nearly two years with no problems, and my experience with other spelling programs makes me appreciate its virtues all the more. WORKS v. 2.0 comes with a speller, based on the Spellswell DA, but it can't compete. It uses a minimum of 45 seconds to check any document, regardless of size, while SPELL will check a document in as little as 2 seconds. I normally check the spelling of my documents in the pauses

between moments of inspiration. By the time a document reaches its final form, it has been checked several dozen times, so I really appreciate fast checking times.

SPELL offers four choices when it comes to an unknown word, either Add, Ignore, Skip, or Change. Add adds the word to the main dictionary, Ignore adds the word to a special dictionary attached to the document, and Skip will ignore the word once without adding to any dictionary. The dictionary of ignored words will stay with the document as long as it lives, and renaming the document using the File/ Save As... menu command will transfer the ignored words to the new document. Choosing Change will, of course, change the word to the one chosen, and SPELL is a very good guesser, easily recognizing transposed letters, my special bane.

It has very good hyphenation ability, and its default settings won't hyphenate a word if doing so would leave less than three letters in the word fragment in either the upper or lower line (this can be changed, but can result in some unsightly word fragments.) It won't hyphenate a word across a page break, and it won't hyphenate the last word in a paragraph. All hyphens added by SPELL are "soft", i.e. not permanent, and will change as you add or delete text. Hyphenation of any word can be changed, if you don't like SPELL's default hyphenation, and SPELL will make your preferred hyphenation the default hyphenation whenever that word occurs again.

You can have spell checking live (as you type), and it will beep at your mistakes, or flash the menu bar. You can also have hyphenation live, but running both spelling and hyphenation live together will use so much memory that it will occasionally run a 1-megabyte Mac out of memory.

There is a Glossary function that will automatically replace a short abbreviation with up to 255 characters of text. For example, I have one that replaces "ra" with my return address. The Glossary will only take abbreviations that are not in any dictionary, and conversely, will not add words to either the main dictionary or the document dictionary that are already glossary abbreviations. Date, day, time and carriage returns can be embedded in the glossary entries. Another really useful thing the Glossary can do is to allow you to

auto-correct common typing errors. My fingers tend to be dyslexic, so combinations like "hte" and "htat", for "the" and "that" tend to pepper my work. To save time and embarrassment, I've created glossary entries for my common mistakes, so now "hte" automatically corrects itself to "the", "htat" becomes "that", und so weiter, and I don't have to worry about running into them the normal five to ten times per page.

COMMAND

COMMAND really astounded me. I was expecting a neat, smooth little program that would make the task of recording macros a little smoother than either the Apple or Microsoft macro recorders. What I got was an entire programming language that makes WORKS several orders of magnitude more powerful and useful. The program will allow the user to replay macros from: (1) an extra Command menu added to the menu bar, (2) from a Window/Run Macro... menu command, or (3) from a CMD-KEY combination. It recognizes 188 different combinations, but care should be taken to not use a combination that WORKS already uses, because COMMAND will override it. This is not a real great danger, since WORKS has relatively few keyboard commands. The lack of keyboard commands is one of the irritants that WORKS has had for me, since my regular job involves using another (blue) computer, and I've gotten used to doing most of the work from the keyboard.

"Recording" is not a adequate description of what can go on in recording a COMMAND macro. You can insert prompts that can later be used to enter text into the middle of a macro playback. Using the Window/Show Macro... menu command, you can edit what was put into the macro, since the macro is shown as a word processing document, and can be changed, cut, pasted, and even checked for spelling. When the macro document is closed, the macro compiles itself, and is ready to run. If the program can't run the macro, it will stop compiling the macro, give an error message and insert three asterisks at the location of the problem, along with a description of the problem. Once the macro is running the way you want it, you can lock the macro document by assigning a password to the Window/Show Macro... menu command. This will only lock the

means of rewriting the macro—it can still be run. This keeps your hard-won macros from being changed by accident, or by mischievous nieces.

Every document in COMMAND can have a one or more macros attached to it. The document has to be open for the macros to be available for use, and the macros can be made applicable to a single document only, to all documents of a single type (word processing, spreadsheet, database or communications), or to all documents of any type. I have found it most useful to have macros on separate documents that I reserve *only* for macros, with a short description of the attached macros on the visible portion of the document. I can then use the macros on more than one document, and not have to remember which macro is on which document when I want to do something special.

Having several macros attached to a short document has a strange effect, especially when encountering it for the first time. The macro document is usually much longer than the normal document, but is not visible until you use the Window/Show Macro... menu command, at which time it becomes visible. The effect is rather like having a 3x5 index card that when turned over becomes a 20-page thesis.

Twenty-nine pre-written macros come with COMMAND, and do some really remarkable things. The macros Make Style and Add Style allow you to define styles and to apply them, and the Resize Picture macro will allow you to alter the size of any graphic element by percentages, or even pixel by pixel, and avoids the distortion usually found when a picture has been re-sized by hand.

FINALLY...

If (and, given my past experience, a BIG if) I can ever manage to decode the programming language, the possibilities of the combined programs would seem to be endless. Spreadsheets can be linked, as can databases, in fact a database could be linked to a spreadsheet, and could update accounting information along with customer information.

There is one major *caveat* needed if you are considering using these programs with WORKS on your Mac. WORKS, SPELL, and COM-

What They Didn't Tell You

An Ongoing Critical Evaluation of Macintosh Software

iruses still happen! Unless you check every bit of software before you open it, you are still asking for big trouble. I had gotten into the habit of checking every new floppy

coming into my system with Virex 1.41 (a commercial program) or Virus Rx 1.4a2 (a program available free from Apple) even though I had never seen a virus infected disc through the heart of the big scare. It is a good thing I do or my system would now be infested with the nVIR virus. You see I finally got the bug fixed MacProof version 3.2.1 I was clamoring for herein last month, but I got more than the upgraded program, I got the nVIR virus at no extra charge. It was lurking in the Apple Font/DA Mover 3.8 program that Lexpertise USA had kindly provided to help move MacProof (a desk accessory) into my DA suitcase. If I had not checked this factory fresh floppy before using it, I would have loaded nVIR into my system too. Both Virex and Virus Rx sounded all their alarms and I found out the new program floppy was infected before opening it and thus avoided infecting my system. A quick call to Lexpertise alerted them of the problem they were sort of in a flap because they had already had several calls that day. They were very nice and sent out a complete new packaged updated program within a couple of days, with new manuals and all (not just an upgrade disc) and a personal apology for the problem. And fortunately -

MacProof 3.2.1 does work as promised (almost)

It will spell check PageMaker 3.02 and save all the formatting. It is the only program that will do so and it is really a necessity now if you like to use PageMaker as a text editor. I certainly do like to compose directly in PageMaker as I mentioned before - one reason - I can type in the 200% scale in PageMaker and actually read this 10 point Times text on the screen without going blind. MacProof also catches double words, and keeps my punctuation reasonably honest. You can set it to check for a lot more grammar problems too, but the more you ask it to do the longer it takes as it assumes you are more and more brain damaged. If you set it to check for everything, it will assume you are in third grade and the resulting dialogs will make you remember how much you hated English then. I set it to just check spelling, double words, punctuation, and capitalization and it makes me look like I have a better command of English than I really do. MacProof 3.2.1 is very useful.

One caution, MacProof does not save the formatting of Word 4.0, although it is supposed to. It translates Word 4.0 documents right back to basic New York 12 text with all enhancements removed. I tried MacProof on this document which is being written in Word 4.0 and your editor would not have been happy with the result if I had not saved a backup copy before experimenting. The advertising writers for software companies have a lot easier time enhancing programs than the programmers do.

Sometimes a program works better than advertised

FontSizer 1.7 is such a program because you can use it for more than they say you can. FontSizer builds high definition screen fonts thus eliminating the "jaggy" look of large font sizes on your screen. With normal screen fonts, the usual largest sizes provided is about 24 point. The screen fonts are composed of little screen dots, not smooth mathematical models as Postscript or other outline printer fonts are. When you select a larger screen font size than what you have in your system, the Mac scales up from the a size that is available, but it scales up the size of the dots too, making the larger sized fonts ugly looking and sometimes nearly illegible.

FontSizer uses a Postscript printer such as the Apple LaserWriter to generate excellent smooth sided screen fonts. It does this by telling the printer to generate a large Postscript font internally, and then it reads that data back into the Mac and uses the big smooth font as a template for building a much smoother screen font. It takes a while to do this as each item in a given font alphabet must be sent to the printer, scaled up, and then sent back and copied. Although the process is automated, it is necessary to go through the whole routine for each new size desired and big sizes may take up a couple hundred K of memory or so.

But when you get done and add Bookman 36, 40, 48, and 52 to your system, for example, then nice things happen. For example, PageMaker will pick a "times 4" screen font, if available, to

display your 200% or 400% screen views. The improvement in screen legibility has to be seen to

be believed. You really get a "what you see is what you get" view.

A major unadvertised bonus is that non-postscript printers such as the new HP Deskwriter will select four times oversized screen fonts, if available, and scale them down when printing. This makes any FontSizer generated large size screen font into a 300 dot per inch printer font when scaled down four times when used with a Deskwriter or similar. All you need is a friend with a Postscript printer to make your own high quality printer fonts from any Postscript font. All this may be mute when Apple System 7.0 becomes available, but FontSizer 1.7 is available right now and it works better than advertised.

SimCity provides interesting way to get around copy protection

Like most games SimCity 1.1 requires a key disc to run and like most recent copy protected games Copy II Mac won't budge the copy protection. I hate key disc copy protection schemes because I have to keep a tray full of key discs around and sometimes floppies fail and then you get to pay the company for another disc just to use the program you already paid for.

Maxis Software, the producer of SimCity, has come up with an interesting method of protecting themselves while allowing power users to get rid of the copy protection. They offer a low cost upgraded color version of the game direct to registered owners only that is not copy protected. The color version only runs on a Mac II or better, it is available only to those who already purchased

the b&w version, and the color is worth the extra cost. Since they got paid twice, they shouldn't mind if the kids keep the b&w key disc for their Mac Plus while the old man plays with the color version. Everybody should be happy.

SimCity itself is a very neat game. You end up being the city manager for a city full of clamoring, demanding, polluting, insistent fools who are always finding something to complain about — sounds like your hometown, no? And about the time you manage to get everybody placated at once, get taxes, crime, and pollution down and industry, housing, and transportation up, along comes Godzilla, a tornado, or a nuclear power plant meltdown to mess things up completely. Maxis does help registered users with a newsletter that tells you useful information such as how to embezzle funds (until the IRS gets you) and poignant facts such as that when the poor little (.3mm tall) Sims die, they are buried in simetaries.

For another additional fee, Maxis will supply registered users another not copy protected program, the SimCity Terrain Editor. This allows you to build your own starting point for a city rather than beginning with one of the many preprogrammed scenarios provided (such as San Francisco in 1906 or Hamburg in 1944) or a randomly generated terrain.

Things happen in real time (airplane crashes, shipwrecks, riots, and floods) and its hard to explain how much fun it is to watch your city grow and see the traffic jams develop. SimCity is a great kids game for adults. Try it, you will wipe out many an evening, along with New York or Boston.

MAND together make such a huge program, especially with the associated dictionaries, resource files, and hyphenation files, that it will not operate well on a 1-megabyte Mac, or on any machine without a hard disk. Hyphenated word processing documents run under WORKS, COMMAND and SPELL will run a 1-megabyte Mac out of memory every time.

I would like to add a personal appeal to this article: if anyone knows of a good book on "C" or "Pascal" for the absolute beginner, I would appre-

ciate knowing about it. It frustrates me no end to see the things I could be doing with COMMAND and not to know enough programming to make them happen.

If you would like more information on an aspect of WORKS, COMMAND or SPELL, or are having problems with any of the programs, by all means come to the WORKS SIG meeting. We normally meet the second Tuesday of each month at the Washburn Community Library, and a large part part of each meeting is usually dedicated to problem-solving.

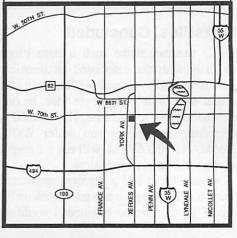

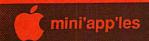
