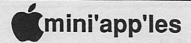

- Tabular (or table) databases—you're all familiar with AppleWorks
- Hierarchical (or tree) databases—I'll introduce PDS*BASE
- Relational (related table) databases— DB Master Professional

Any of these three types (and yes, there are many more) have their own strengths and weaknesses. This all depends on the application you have. In any case, if you are going to set up a serious application for business or personal use, there are some tasks you can do up front to avoid problems down the road. These tasks—some know them as data modeling—can help you identify whether the application you have will work properly on the

Apple // Telecommunications Downloading and File Processing...

Have you entered the exciting world of telecommunications with your Apple // and modem, but cannot quite get a handle on transferring files? Do not despair-wading through all the terminology and techniques involved is not as hard as it may seem. However, there are some basic concepts and techniques you will need to understand in your quest toward transferring that first file. Downloading a file refers to transferring a file from the remote computer down to your local computer. Uploading is the reverse, sending a file up to the remote computer from your local computer.

In the last couple years downloading files with an Apple // has become a bit confusing. The actual process of downloading the file is not much of a problem, but how to get the file to run is the difficult part. The first concept—which has not changed—is that files on the host computer are stored as text files. This is because more often than not the remote computer is not an Apple //, and the files you download require some type of processing before you can use them. It used to be that all you needed to do was use the command "EXEC <filename>" on the text file on disk after you downloaded it. This command would read the text file into the computer memory as if you typed the information in using the keyboard. When this process was finished, you could simply save the file to disk as if it was a program you typed into the computer memory. This procedure worked fine in DOS 3.3 days.

Terminology that you will come across on various BBSs (computer Bulletin Board Systems) and information services is sometimes quite intimidating. Thankfully the Apple telecom-

munications world is now minimizing methods and terms to ease the confusion. Arguably the most frequent and important word tossed about is *protocol*. Protocol refers to the method two computer systems use to communicate. In the world of politics a very definite procedure is followed when two countries exchange information. In much the same way, computers follow a procedure or protocol.

There are several different protocols computers can use, but by far the most common is x-modem. The original x-modem protocol (x-modem checksum) has some limitations so individuals have expanded it to make it more useful; therefore, you will most generally see the term x-modem followed with some kind of modifier (for example; x-modem CRC, x-modem ProDOS, x-modem DOS, etc.). A few other common protocols are y-modem, Kermit, and SDCII.

As you can see, just determining which protocol to use when transferring files can be a major chore. To make your life easier, stick with x-modem protocol without any modifiers for your first file transfers. Actually, x-modem can be used for all your future file transfers with great success as long as its limitations are fully understood. Most of these limitations can be very handily overcome with a highly praised and embraced procedure that creates Binary II files.

[Note: The following section gives some detail on the BNY file format. As quickly as BNY became a standard in the Apple II world, it was replaced by another format, SHK, by Andy Nicholas. I've left the information in the article to keep the article complete as it was written and also felt that it provided good background information on the evolution that has taken place in Apple II telecommunications.

Generally, as you see BNY used in the remainder of the article, you can just as easily replace it with SHK (ShrinkIT)—Tom Gates]

The Binary II, or BNY (pronounced Bunny), file format is rapidly becoming the standard in the Apple world and for good reason. All files stored on a BBS for public access are stored as TEXT files. As you may know, not all files used by Apple computers are TEXT files, in fact the majority of them are not. The more familiar files under ProDOS such as BIN, BAS and SYS need supplemental information called file attributes for the program to function on the Apple computer. Several of these file attributes are the file type, creation date, modification date and auxiliary type. These attributes normally reside in the directory of the ProDOS disk and not within the program file itself.

Because of this fact, when a program file is transferred via x-modem, these attributes are left on disk and not transferred with the program data. The Binary II packing scheme simply creates a new file that contains not only the program file, but also the file attributes found in the disk directory. When this BNY file is transferred, it now contains any and all information that ProDOS needs to access the original program file.

An interesting feature of the Binary II format is that it allows bundling together of related files. For example, a program along with its documentation can be bundled for transmission which obviously greatly assists the end user. Another very exiting feature of the Binary II format is the preservation of important information within AppleWorks files. Reports, layouts, document formatting and spreadsheet formulas are all

preserved in a file that has undergone Binary II formatting.

These unique features as well as the ease in which Binary II files can be created and later unpacked is in no small measure why the format has enjoyed such wide acceptance.

A Binary II file in its packed form is useless as a program file. It must be unpacked to install the program's file attributes within the ProDOS disk directory. Graciously, the author of the Binary II format, Gary Little of Point to Point fame, has released to the public domain all the necessary utilities to accomplish this task.

Since the Binary II format is so popular, many telecommunications packages have built into them the capability to unpack files received in this format. A few of these notable packages are Talk Is Cheap Datalinker, ProTERM MouseTalk and Freeterm GS. Many other individuals have written and released utilities to the public domain that create, as well as unpack, Binary II files. Probably the most popular and easiest to use utility in this category is BLU (Binary Library Utilities) by Floyd Zink. Note: The ShrinkIT programs for the Apple II and the IIGS already have these type of utilities built right into the program.

The Apple world owes a great debt of gratitude to these gentlemen for the contributions they have made for the advancement of the Binary II/SHK format. In the case of Gary Little, the tremendous impact of his development of the Binary II format will be felt for many years.

The utilities written by these people can be found on most BBSs and all the information exchanges. Variations of BLU are ALU (Apple Library Utility), Librarian, ACU (AppleLink Conversion Utility) and ShrinkIT.

[Note: mini'app'les keeps current versions of ShrinkIT and other telecommunications utilities on its own BBS. They are also available on disk through the eDOM library as part of the "Disk Exchange Program". —Tom]

ShrinkIT, as the name implies, is preeminently a file compression utility although is does simultaneously archive multiple files (or entire disks) in a single file of ProDOS type extension .SHK. ShrinkIT uses a compression technique called Dynamic LZW which "shrinks" most files (except picture files) to a considerably greater extent than does the Huffman Squeeze. ACU and ShrinkIT-GS can pack files containing resource forks. i.e., files for the Macintosh and GS/OS. The NuFX protocol, so far only represented by ShrinkIT-GS and the NuFX program, also allows resource forks to be bundled. The latest versions of ShrinkIT can handle most all of the previous formats and therefore has made it the current standard.

There are many valuable programs in the libraries of the BBSs throughout the country and even the world. Now that you have a little better grasp of the terminology of file transfers, you will be able to access this wealth of information. By all means start with the local BBSs and go from there to wherever the telephone utilities touch another computer. Enjoy the freedom and value you Apple and modem offer you.

Since this article was originally written, ShrinkIT and ShrinkIT-GS have become the Apple II/IIGS standards. Also, Andy Nicholas is now an Apple employee working in the software area. Speculation is he may be working on incorporating ShrinkIT-type file compression directly

into the GS/OS and/or ProDOS system software.

This would have advantages for users of hard drives and even 3.5" users. Having something like ShrinkIT built directly into the system software would allow these users to store program and data files in compressed format. As the program files are run, or data files accessed, the system would automatically expand these files to their normal size for use. Then, say as a data file is resaved, the files would again be compressed for storage. Thus saving lots of precious storage space on those drives.

The IBM and Mac machines have had similar run-time compression programs for some time. But compared to those I've seen, ShrinkIT is blindingly fast. As an example, ShrinkIT expanded a full 3.5" disk, that was compressed to 35% of its original size, in less than 40 seconds. That's faster than a lot of disk copy programs doing "from memory" disk duplication.

Where I'm headed here is that I don't believe products like ShrinkIT will be staying only in the telecommunications realm. I hope and expect that they will begin to work their way into the operating systems of the Apple II and GS. There they will still provide telecommunication functions as they do today, but will also grow and become integral components of the operating systems.

Home, small business and school users have found that mass storage prices have dropped considerably over the last couple of years and many of them have taken advantage by buying hard drives for their Apple II and GS systems. But it still isn't free or really cheap. But, with a little tweaking and a few add-ons to the operating system, wouldn't it be great to routinely put 30 megabytes of files on that 20 megabyte hard drive? —Tom

HyperCard IIGS supports multiple media by letting users work with information in virtually any form, including text, graphics, video, sound and animation. It also takes full advantage of the advanced 16-color graphics capabilities of the IIGS.

To allow customers to begin immediately using the software, the program comes with a large collection of ready-to-use stacks—plus templates and card designs to help individuals create their own stacks. The program's scripting language, HyperTalk, provides buttons, cards, stacks and utilities such as debugging tools to facilitate creation of sophisticated programs and speed the preparation and performance of user-designed HyperCard stacks.

With HyperCard IIGS, Apple IIGS customers have the full functionality of Macintosh Hyper-Card version 1.2.5—plus specific enhancements to improve performance and take advantage of the color capabilities built into the Apple IIGS. They can also enjoy the additional benefit of accessing the many stacks that already exist for the Macintosh once developers convert them for the Apple IIGS.

For most of us, when you mention AppleWorks the words productivity or business come to mind. The last thing you probably would think of is education.

We all know that our schools use Apple II's in a variety of ways for education. The meeting room we use at Murray Jr. High is a prime example—there must be twenty or thirty Apples installed there alone. What a lot of us have failed to realize is that AppleWorks has become a valuable part of the educational process.

What brought this to my attention was Claris' recently released second edition of The AppleWorks Resource Guide for Teachers and Parents. I sent for the book thinking it was an educational approach to teaching AppleWorks. It turned out to be education with AppleWorks! The inside front cover describes it best - How to Find and Use Materials for Teaching with AppleWorks and AppleWorks GS.

First published in 1988, the Resource Guide could be considered a catalog or reference book of who's who and what's what for AppleWorks. The secondary purpose of the Resource Guide is to trigger new ideas. We all know how flexible AppleWorks can be. Given a different approach and a few new ideas who knows where AppleWorks can take us?

The Resource Guide is divided into sections dealing with available templates, how to write and use templates, example lesson plans and lists of additional resources, publishers and suppliers.

The templates (over 140 of them) are separated into classroom and teacher utility groups. They are listed alphabetically by name with indexes to cross reference subject area and grade level. The templates cover grades 1-12, and the subject areas used are language arts, math, science and social studies. The source and price is also identified.

There are ten lesson plans provided, built on using templates for instruction. The subjects include "What's So Periodic about the Periodic Table of Elements?" (grades 9-12), "The Planets" (grades 6-9) and "All About Me" (grades 2-4). Reviewing these lesson plans provided a very refreshing look at new ways to use AppleWorks.

The resources include a mindboggling list of 80+ items of hardware, software and books related to AppleWorks and AppleWorks GS. There are also names, addresses and phone numbers of nearly fifty suppliers of these products.

"Flow Control Cable" Connects a Mac to an RS-232C Modem

Macintosh Hardware/ Telecom In late January, "Micro Merchants" on GEnie offered a V.42bis modem for an outrageously low price. In the process of checking up on this modem, I found that I would need a special "flow-control" cable for my Macintosh Plus.

(Since I already had a modem, I didn't need to purchase one for myself, but my friend had asked me to purchase it in his behalf, and test it out.)

If you've had your computer for any period of time, you will no doubt have noticed various articles from time to time regarding hooking up a RS-232C serial cable to the Mac's RS-422 serial port. (One example appears in *MacUser* February 1989.) At the risk of appearing to beat on a dead horse, this is another such 'article.' The difference is that I intend to tell you how to make a "flow-control" cable, as opposed to the more conventional and simple cables. It should work an virtually any modem, especially the newer data compression-type modems. The figures below explain what I found out.

Note: The shielding from the cable should somehow be connected up to the shielding on the connector!

* Both Pin 4 and Pin 8 on the Mac should be connected to Pin 7 on the modem.

\$249 Accelerator

At MacWorld Exposition Brainstorm Products demonstrated an innovative bus accelerator upgrade for compact Macintoshes which delivers Mac-II performance for only \$249.

Unlike existing accelerators for the Macintosh, the Brainstorm Accelerator™ not only adds a specially designed high-speed 68000 processor clocked at 16MHz but also re-configures the Macintosh bus to run at 16MHz, allowing memory and input/output chips on the Mac's motherboard to run at the same speed as the 68000. Existing accelerators do not increase the operating speed of the bus beyond its original clock rate of 8MHz, and are thus forced to slow down to accomodate the slower memory and input/ouput chips on the motherboard.

The Brainstorm Accelerator triples the speed of graphics operations and increases SCSI hard drive transfer rates by as much as a factor of five.

Computationally intensive processor tasks, such as recalculating a complicated spreadsheet, are accelerated by a minimum factor of of 250%.

At the core of the bus accelerator's design is a proprietary high-density Application Specific Integrated Circuit (ASIC), which takes control of key timing signals on the Macintosh motherboard. "The bus ASIC and a 68000 at 16MHz allows a Plus or SE to run 28% faster than a Mac-II; it also reduces our design to a two chip system, which is super-reliable and costs less than a fourth of comparable 68020or 68030- based systems," said David Zampino, Brainstorm president.

The accelerator for the Macintosh Plus is scheduled to ship in mid-February, while a ver-

Mac Beginners: How Do I Cope at Kinko's?

Macintosh Hardware and Software



by James Horswill © 1991 I'm sure that many of you who read this Newsletter are using an ImageWriter to print your documents. While the ImageWriter is a fine printer, there will come a time when you will need 300 dpi output, and at that point you may either have to find a friend who owns a laser printer, or make a trip to a place like Kinko's.

Kinko's is a chain of copying centers where you can rent a Mac and a LaserWriter for a few hours. This means that you can get 300 dpi output any time you need it. (I mean that literally. At least some of Kinko's outlets are open all night). Of course, Kinko's is not the only business offering these services. Many others offer Mac and printer rental, some at a very sophisticated level. The Electronic Easel has Mac II's, scanners and color printing, for example. I suspect most novices go to Kinko's, however, so I'll use it as my example. What I have to say applies equally to the other services.

At Your Home or Office Selecting a driver

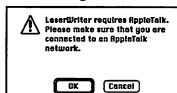
Let's assume that you are writing a simple report in MacWrite. If you're going to print it at Kinko's, you should plan for that from the beginning. As soon as you open MacWrite, go to the Apple menu and call up the Chooser. If you normally print on an ImageWriter, you will probably find that it's selected. Select the LaserWriter instead.

Adding items to the Chooser window

If you don't find a LaserWriter icon in the Chooser window, it means that there is no Laser-Writer driver in your System folder. Close MacWrite, and insert the Printing Tools disk. It's one of the System software disks that came with your Mac or that you have purchased from the Club or a dealer.

(Note: System software on 1.4 meg high-denisty floppies may be labelled differently.) Drag the icons for the various LaserWriters into the System folder on your startup disk, and restart your Mac.

Let's assume that you have a LaserWriter driver showing in your Chooser window. There may be more than one, depending upon how many you placed in your System folder. Select the LaserWriter icon, and you will see this dialog:



Click OK. I know you're not connected to an AppleTalk network. Pretend! You'll see another message that tells you to open Page Setup. Do that too. It's under the file menu. You should choose Page Setup every time you change printer drivers, because this tells the Mac about the change.

It's important that you use the LaserWriter driver while preparing your document, because the Mac formats documents differently, depending upon which printer driver is currently active. If you prepare your document with the ImageWriter selected in the Chooser, and then try to print it on a Laser-Writer, line and page breaks may change.

Selecting typefaces
It's also important that you use the proper fonts in preparing your document. Be sure that you don't use ImageWriter (bitmapped) fonts. They're the ones that are named after cities. Common ones are Geneva, New York, Monaco and Chicago. If you use any of these fonts, the LaserWriter will either print them at 72 dpi, or substitute

other fonts for them, depending upon what options you choose in the Print dialog.

[Editor note: In the beginner's world, the "city" generalization noted above is still accurate, but it is becoming less reliable for people who work with large font libraries. Many new laser fonts are named with no regard for the city rule.]

You should also be aware that the LaserWriter you use will probably only have the built in LaserWriter fonts called "resident fonts." These are Times. Courier, Helvetica, Helvetica Narrow, Symbol, Avant Garde, Bookman, New Century Schoolbook, Palatino, Zapf Chancery, and Zapf Dingbats. If you use any fonts other than these in your document, you will have to bring them to Kinko's. The manual that came with the fonts will explain how to download them to the printer. Don't forget to bring the **Downloader** utility—it should be on the disk with the fonts.

Two kinds of screen fonts It's also a good idea to use the Apple versions of the screen fonts for whatever fonts you're using in your document. Fonts designed for use on laser printers are sometimes referred to as "outline" fonts, for reasons which needn't concern us here. Each comes in two parts: a screen font and a printer font. The screen font is a bitmapped version of the font, and the Mac uses it to draw text on the screen. The printer font is what the laser printer uses.

The screen versions of the standard LaserWriter fonts that I listed above all come in at least two forms: Apple and Adobe. The Apple versions are the ones that you get with your System disks. You get the others when you buy the fonts from Adobe. (A number of them come with Adobe Type Manager, for example). The problem is that

Kinko's uses the Apple screen fonts, while you may be using the Adobe versions, especially if you use Adobe Type Manager. This can lead to subtle changes in output. I keep a separate suitcase file on my Mac that just has the Apple screen fonts in it. I use Suitcase II to open this file, and close the file with the Adobe versions, whenever I'm going to print a document at Kinko's. Of course, there is always the possibility that the Kinko's you use has changed to the Adobe screen fonts. All you can do is ask what they're us-

Apple doesn't provide the screen fonts for most of the standard LaserWriter fonts on the System Disks. However, they're free, and most Kinko's outlets will supply them to you if you bring in a formatted disk. Having these extra screen fonts on your Mac means that you have a far wider choice of fonts from which to choose. Don't use too many in one document, however, or you'll be guilty of "ransom note typography," a tasteless jumble of typefaces.

Previewing on an ImageWriter

Now you can create your document just as you normally would.

If you wish to "preview" it with your ImageWriter, select the ImageWriter icon in the Chooser, and choose Page Setup from the file menu. Be sure that you choose Tall Adjusted. This assures that the output you get from the ImageWriter will be as close as possible to what comes out of the LaserWriter. Do not save these changes.

Final preparations
Now you're ready to go to
Kinko's. Save your file to a disk
and lock it. This assures that
you won't pick up a virus while
you're there. Of course, if you
have to make changes to your
file after you arrive, you will
have to unlock your disk. In
this case, be sure to scan it

with virus protection software when you get back to your Mac. I know that Kinko's has protective software installed on their Macs, but this is one area where you can't be too careful.

Be sure that Kinko's has the application you will be using. This isn't a problem if you're working with old standbys like MacWrite or MacDraw, but you should call ahead if you plan to use a less common program, like Canvas. You may have to bring it with you. Be sure that you also have any ancillary files that the application needs. I once went to Kinko's with the newest version of Microsoft Word, only to discover that it wouldn't hyphenate my file without the hyphenation dictio-

It's a good idea to call ahead for a reservation. I use the Kinko's in Dinkytown, and at finals time, you can have a long wait. It's also wise to make sure that the Kinko's you're going to use has Macs. Some of them are just copy centers.

At Kinko's

Be sure to preview your document after you get to Kinko's. Make certain that margins and page breaks are where you intended. If you should discover an error, by all means correct it (you'll have to unlock the disk to do so), but remember to change any other copies of the file you may have as well.

If you've prepared your document properly, printing it should be a relatively straightforward matter. However, remember that the printers at Kinko's are on an AppleTalk network. That means that several Macs may be using the same one. If there are several documents ahead of yours, you may have to wait a bit. Also, be aware that documents with complex graphics and formatting may print very slowly.

Follow these steps and you shouldn't have many problems. If you do experience difficulties,

by all means ask for help. I have found the people who work for Kinko's generally knowledgeable, and if they can't help you, someone at an adjacent machine may be able to do so. If someone should ask you for help, please give it, if you can. They may be even more confused than you are.

vertical line in the margin saying that something has changed). You may include or ignore hidden text, footnote numbers, automatic paragraph numbers and hard page breaks. DocuComp even allows you to add your own notes to the comparison, but will never alter your original files.

About document comparison

People have wanted to compare different versions of their computer files as long as they have had computers. Various "diff" utilities have been available as a part of many operating systems. The problem was that they didn't work very well with word processed text that wraps from line to line or on text that was moved from one place to another. DocuComp was written by Dr. Cary Queen, a theoretical mathematician and molecular biologist who was one of the first scientists to analyze DNA sequences with computers. Some of the techniques he used in building a DNA library were applied to DocuComp, but he says that DocuComp is the most difficult thing he has ever accomplished.

Meet HyperCard 2.0, Make a Global Stack, and Other Matters

I'm baaack! Well at least for this article. And the reason? HyperCard 2.0. Are you using Hyper-Card 2.0? Are you using HyperCard? If not, I only have one question for you. Why not? You reply "Yeah, why should I Jason?" Well....first things first. First if you use HyperCard, but haven't made the switch to 2.0 yet, this column is for you. I'll tell you all about how to do it. Second if you haven't used HyperCard yet, but need a little prodding, then this column is for you because the same discussion still applies. Need some endorsements for HyperCard first? Let me just say that HyperCard 2.0 is pretty stunning. Sure it still needs some things here and there. But all in all, if someone told me that I could have only one piece of software on my Mac, I'd pick HyperCard 2.0. With it I could still write this column, I could still create graphics, I could still create black and white page layouts, I could create custom games, I could go on and on, and I'd still be pretty happy!

How to get HyperCard 2.0 Up and Running

First you need to be using System 6.0.5 or greater. Don't wait! Do it immediately! Hyper-Card 2.0 waits! And you will be waiting for System 7.0 for too long otherwise. I'm not going to tell you how to do System upgrades here, call your dealer (it's free—you should know that). Ok. You've got System 6.0.5 now and you've got HyperCard 2.0. Now, for those of you who have been using HyperCard before this momentous occasion, copy all the stacks you'd cry about if you lost, including your Home stack. I say this because it's a good idea, not because I've had HyperCard 2.0 (HC2 from here on thank you very much) corrupt any of my stacks yet (it hasn't). Second, and this is a biggie, rename your present home stack something else like, "Global Stack." The reason "Global Stack" is a good meaningful name is because with HC2 you can start using stack "Global Stack" to allow its scripts and resources to become available at all times no matter which stack you happen to be in. (for those in the know, these stacks work just like a single home stack did in the HC1.x days.) The idea here is to keep all your specific scripts and resources that you used to put in the Home stack into a "Global Stack". Then you can keep your Home stack relatively clean and easily replace it with others that Apple...I mean Claris...may release in the future. If you are new to HyperCard, don't fret, you can create your own "Global Stack" in a minute. Now you can copy HC2 on to your hard

disk. (You do have a hard disk don't you! No? Geez this is the 1990s.. Hard disks are not free, but they're worth it!). Double click on HyperCard 2.0 and you see your new Home card (I like it, I like it!).

Make a Global Stack

Ok. Now, if you're new to HyperCard click on the HyperCard Tour button. Do it now, become amazed (remember everything you'll be seeing is HyperCard at work) and then come back. Next, pull down the File menu and choose New Stack..., name it Global Stack and go back Home (Press command-h—Hey you're using HyperCard! If you ever need help choose the Help item from the Go menu).

Ok, next (everybody now) press command-4 to go to the last card, click on the big 5 to allow scripting, and type in your name near the top of the preferences card. Press command-1 to go back to the first card (For you newcomers command-1 (cmd-1 from here on, thanks) always brings you to the first, cmd-2 to the previous, cmd-3 to the next, and cmd-4 to the last card in the present stack. Try typing into the message box nav"—this brings up a new palette of navigation buttons for moving around HC—pretty cool uh!

Now we are going to edit the script of your Home stack (the Home stack provided by Claris—nobody is confused are they?) Pull down the Objects menu and choose Stack Info... Now press the Script button. Wow! A real window showing a script (that's for you HC types). Scroll down a little till you see this script:

I added the stack Power Tools that Claris gives you too. It's got some neat stuff, and you'll want it also as a global stack always available (Yes you can have more of these type of stacks!) This is the only change we'll make to your Home stack script. You shouldn't really make any others either, because from now on your Global Stack takes its place for where to put handlers you always want available. (Handlers are the individual sections of code in a script starting with "on" or "function"). Now let's go edit the script of your "Global Stack". Choose menu item Open Stack... from the File menu and pick your "Global Stack" from the file list. We need to convert this stack to HC2 format now (remember to save copies of any stacks you want to convert first and then convert themyou'll never be sorry—'cause you're never going to run the old HyperCard again!) Pull down the File menu and choose Convert Stack. Ok, now pull down the Objects menu and choose Stack Info...and click the Script button (got it now?). If you copied your "Global Stack" from your old Home stack, then delete the handlers that Apple had put there (if you never added any of your own then delete them all!). Be sure to delete the startup, resume, getHomeInfo, and searchScript handlers.

step: In order to activate the script of your Global stack, restart HyperCard. It will execute the start using stack line in the startup handler, or type the line into the message box.

Creating your own stack
In my last article (last May or so, gasp!) I wrote about how to start creating your own stacks.
Because of the theme of this article I think it's appropriate to repeat that section here. It's easy, it's fun, and most important you'll enjoy it!

Five Steps to Create Hyper-Card Stacks

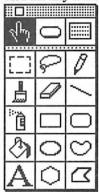
- 1) Choose "New Stack" from the File menu and name it.
- Choose Background from the Edit menu and then choose "New Field" from the Objects menu.
- Resize and move the field to some location. (See the HyperCard doc for how to do this.)
- Name each field and make it either a rectangle or scrolling field for now. (Double click on a field to do this.)
- 5) Choose the browse tool and enter some data!

Now you have a working stack! Use the navigation palette (type nav into the message box) to move around. To speed up this process you could begin by copying another stack in the first place. The Stack Templates stack found in your HyperCard disks is also a good place to start. The key is never to let a problem stop you. When you can't seem to figure out how to do something, don't shake your head thinking "The computer generation belongs to the kids!". Shake your head and say "I'll start with the index in my manual." The Mac is notorious for making people believe that manuals are obsolete, but that is ridiculous. What is true is that the Mac is the easiest computer for a beginner to use with little resort to manuals. However to do really useful work and to begin to understand your computer, a manual should be

readily used, not scorned.

In HyperCard there are three tools that everyone should learn to use as early as possible. They are:

- The Browse Tool— HyperCard's default tool (and everyone's favorite)
- 2) The Button Tool—Used to explore and modify buttons
- 3) The Field Tool—Used to explore and modify fields

These three tools are found at top of the Tools window (or Tools menu). By setting the userlevel to 5 (To allow scripting permission-Enter "set userlevel to 5" in the message box) a HyperCard user can poke around stacks with abandon. Don't be shy! (Though copying a stack of importance beforehand would be prudent.) Once you have a stack started and have begun to enter data, you'll begin to have more ideas of how it should work. From here just read documentation or poke around in other stacks to find the how to do what you want. Soon you'll be programming HyperCard with the best of them! As the Roman rule says, "The one who says it cannot be done should not interrupt the one who is doing it!"

Yo Later!

There is a lot of neat stuff to play with in HC2.. I hope to be back soon to talk about them. Creating your own palettes would be a fun thing to do—ummm?

Making your scripting easier

Oh! I hate when that happens...

Bugs, bugs, bugs. Every new program release has its share, and some more. Early indications from those messing with the final beta releases of Hyper-Card 2.0 suggested that it made a clean transition in converting most all of your earlier stacks to 2.0. Shortly after its official release, however, I began to see some users' comments (nay, screaming reactions of despair!) that all was not right in HyperLand.

I am certainly no "power user" of the program, attempting to push it to do herculean data management tasks with its attendant complex scripting, but have encountered a few strange things in my own slow and lumbering way.

Some (perhaps all) of the "anomalies" relate to new features within the program. My latest encounter was with a converted stack that lost track of backgrounds. This seems to relate to some of the other bugs that I read about, even to the extent that some (obviously accomplished HyperCardians!) were writing their own "conversion" routines to move stacks from 1.x documents to 2.0.

My short list is nothing, compared to the list of things that were on the "official" bug correction swatlist for HC 2.0v2. Here's a couple of personal encounters of the HyperCard kind, just to let you know that extraterrestrials probably haven't inhabited your converted stacks... just a few bugs:

• A time routine which worked in 1.5 came up with some aberrations after conversion. I still haven't squashed this one, although the new "dateTime" function may hold the key. You (apparently) still need to set the system clock to 24 hr format to get it to recognize a number format

such as "10:33:46" as 10 hours, 33 minutes and 46 seconds. However, the variable "50:35" was not seen as a min:sec time number. It acted like HyperCard was trying to read it as 50 hours and 35 minutes but rejecting it because there are only 24 (not 50 or more) hours in a day. Forcing the number to "00:50:35" made it OK, and the add-up routine accepted the numbers if broken up to a series of "20:00, 20:00, 10:35", totaling them correctly as "00:50:35".

More perplexing, is a problem with the "new card" routine recognizing the correct background after being converted. I thought that the stack made a successful conversion, and worked with it for some time polishing its graphic appearance. When I tried to add a card, handlers that referred to a specific background ID complained that it was not there, even though inspection of the "Info" for the background said that the ID was correct. The "final solution" to work around this required that I duplicate all of the cards of the errant background, delete the old cards and change the handler references to the ID of the newly "cloned" background. End of complaints.

Don't kill the messenger...
I've been starting to work with
HyperCard system messages to
trigger action, such as adding
up a series of numbers when a
field is closed rather than needing to click on a button to do
the addition.

"Whoops!", you say? What is a "message" and how does it get sent? Who gets the message, and what happens with it when it's received? Those are all good questions, but I'm really not very versed in providing all the answers for you, much less all the right answers. But here's a bit of a rundown, as I currently understand it.

- HyperCard sends messages in response to any suspicious activity. Matter of fact, it is even sending messages when you are not initiating any activity. It's yelling up and down the HyperCard Halls that "nothing is happening" and the HyperCard engine is "idle." Push the button on the mouse and a new gaggle of messages goes out (briefly) that "the mouse button is down." Moving the mouse, clicking on the screen, clicking on text, moving to another card, leaving a field... all these, and more, have associated "messages" that ring through the halls to let all of the nooks and crannies of HyperCard know just what is happening.
- Messages have a defined order of where they are first passed to and where they go next. Basically, they start with the buttons or fields on a card. They pass from there to the card, then to the background, then the stack you are working on, to the "Home" stack and then to the great arbitrator, HyperCard itself. If a message is caught by a "handler"... for instance, an "on mouseUp" script in a button where it triggers some action... that ends the message, since its usefulness is presumed to be over at that point. If not caught somewhere along the path, the message finally gets to HyperCard, where it is discarded if it's a legal message, or may trigger a dialog box to alert you that a non-legal message wended its way through the HyperCard halls.
- You can initiate a message in a script, rather than by remote control of a button push or mouse move, and send it to a specific place or just holler it out hoping for it to be caught somewhere else.
 You can also catch a message in a handler you write, do some action in response to it, then breathe new life into it

by "passing" it along so other handlers have a chance to react to it.

If you are aware of the "automatic" messages that Hyper-Card sends as objects are manipulated, you can "listen" for them in your handler script and cause action to occur without the deliberate need to "push a button" to trigger the action.

That's what I meant in the opening of this HyperByte. By knowing that once I had entered a series of numbers in a field, exiting the field (as with a tabKey press) sends the "closeField" message. Placing a handler in the script of the field (or some other place in line to hear the message) that begins with "on closeField," then totals the numbers without the need to take a specific, separate action to add them up, because it is triggered by the "closeField" message that it receives.

There's a lot more to this than I've touched on here: where do you place a handler so it will catch the message that you are looking for; what are the messages; which ones should you pass along; when should you send out your own message and more. If you really want to wring a bit more out of Hyper-Card, this is a good area to explore. Pick up one of the "how to" HyperCard books for more detailed (and undoubtedly more accurate) information on messages and scripting. Or, bring your questions to the next HyperCard SIG meeting (check the Calendar of Events in this newsletter for time and place).

Finally, you can make the computer do something for you, instead of the other way around.

Whoops...

I goofed. In an article for the newsletter about the "patched" HyperCard 2.0 issued by Apple with Macs (beginning about October of '90), I provided a series of steps that you could take to gain full utility of the program. The steps began by suggesting that

you perform some minor surgery on a "copy of the program." Actually, all that you need do is make a copy of the "Home" stack, rename the original "Home" stack to "OldHome" stack (or some other name that fits your creative juices, if you don't like cottage cheese) and then rename the "Copy of Home" stack to "Home" stack.

It is the stack provided by Apple that "limits" your value received, and not the application "HyperCard." These two items, however, are inexorably linked so tightly that it is hard to think of them as separate entities. Nonetheless, modifying a "copy" of the "Home" stack is what I should have said in the article. If my unthinking linking caused you any trouble, I apologize for any confusion it might have entailed. If you have any lingering problem from it, contact me immediately (612/ 478-2300) and I'll get you back on track... (or should that be "stack"?)

A Portable Light For My Mac Portable?

I love my Mac Portable. Yes, it's heavy and overpriced but still it IS a Mac. I do have problems trying to see the screen in dim light. Apple spent millions coming up with state-of-the-art screen technology, but someone failed to realize that all of us would not be using the portable on a sunny Cupertino afternoon.

There is a solution thanks to all those insomniacs who read in bed. It's called "Beam & Read."

BEAM & READ



B&R is a portable night light designed for bedtime readers but can be used for any activity where you need a small but powerful focused light. B&R is designed so that it hangs around your neck resting on your chest like a medallion.

The unit is one piece but the actual light is a small, adjustable rectangular box that flips up and throws a powerful beam of light. Inside, the large soft white reflector diffuses the light for wide area dispersal. The beam spread covers the entire Mac Portable. The powerful Ektron bulb (two additional bulbs are included and a standard 4.8 volt screw base bulb can be used also) automatically goes on when you flip the light head up and goes off when you close it.

An adjustable strap, combined with the adjustable light, gives you all the angles you need for proper viewing. However, you do need to find the proper viewing angle so you don't get hit with glare on the screen.

The unit takes four double AA batteries. A back panel slides open for installation and there is room for storing a spare bulb. The unit also has an AC adapter jack so that you may use it with a lighter plug in your car, or a 120v or 220v house current. I don't know how long a bulb will last but I am impressed with the bulb's brightness.

I looked at a number of different kinds of portable lights that might do the job and the Beam & Read is the best I found so far. By hanging around the neck it doesn't get in the way of typing, nor do you need to attach it to the Mac. It broadcasts a wide area, and is a powerful and steady beam of light. I turned off all the lights in my room and the B&R was strong enough to let me type without any strain. Naturally, you wouldn't want to use the B&R for hours at a time but for those occasional times when you need it, it's nice to have. It's small compact size fits neatly in the Mac portable carrving case, and even fits into your shirt pocket.

The Beam & Read is made by EK Success LTD, 611 Industrial Rd, Carlstadt, NJ 07072.I bought mine at a local Waldens Book store for \$14.95. Prices may vary depending on your location. B&R has a one year limited warranty.

So if you own a Mac portable and you find yourself in situations of low light, a Beam & Read is an inexpensive alternative to eye strain.

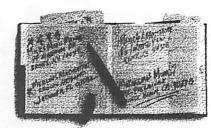

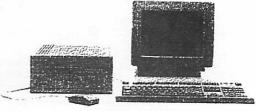
