





#### Topic: "Get your hands on BulkRate"

The next Telecommunications SIG will be held on Thursday, May 1 and our topic will be "Hands on BulkRate".

Bulk Rate, sounds like something you do at the Post Office. Well, in a sense that's what it is. The difference is that here we are not dealing with a bunch of letters, but a bundle of electronic mail. Instead of spending time looking in various folders for something we want to download, we can simply select the folders (Conferences) we are interested in and transfer that information to our computer. For example, let's say we want to follow what is going on in the Mac Talk Software conference on our BBS. Using BulkRate we can select the Mac Talk Software folder and have the information automatically transferred to our computer the minute we log on. We can also use Bulk Rate to select information from

multiple folders and have it automatically downloaded. The advantage is that we can select a number of conferences we like to follow and BulkRate will go out and download only the requested information. This saves a lot of on-line time which makes it possible for more people to

use our BBS.

Therefore we like people to bring a PowerBook or portable computer so we can set up BulkRate on their machine for them to use.

Let's get into Telecommunications!



Jacobson, has volunteered to run for Club President, the Digital Imaging SIG will include Photoshop on alternating months for a while.



Before you buy anything, see if Bottom Line http://www2.blol.com/bld\_home.t?level=s has it. If not, send email to Bottom Line's New Products mailto:new@blol.com address. Bottom Line promises to take 10% off that item.

Other World Computing http://www.macsales.com/ has, in stock, the Apple PowerMac systems 7300/200 16/2.0/12x for \$2,549. As always, OWC's prices are credit cardfriendly. This is the lowest reseller price we know of, trumping even Absolute Mac's http://www.absolute mac.com/US/PRIX/US/MACHINES/PowerMac\_7300\_200.html best when adjusting for cash discounting.

MacInTouch http://www.macintouch.com/ reports that several Apple systems aren't readily available to dealers. Among them: the PowerMacs 7300/200, 8600/200, 9600/200, and 9600/200 MP, and the PowerBook 3400/180 with Ethernet.

Buying-a-Mac http://www.digis-

erve.com/buying-a-mac/ reports that the 7300/180 and the 9600/200 are indeed shipping in quantity, the 7300/200 is shipping but scarce, and the 8600/200, 4400, and 9600/200 MP are not yet shipping. Note that OWC has the 7300/200 in stock, above.

Buying-a-Mac http://www.digis-erve.com/buying-a-mac/ reports that Power Computing has dropped prices on its PowerCenter 150 by about \$100 each. LP=low profile; MT=mini-tower. All include 512k cache, 8x CD-ROM drive, and 2MB VRAM.

Model New price PowerCenter 150 16/1.0 LP \$ 1,495 PowerCenter 150 16/2.0 LP 1,590

PowerCenter 150 16/1.0 MT 1,595 PowerCenter 150 16/2.0 MT 1,690

Power Computing also appears to have discontinued the PowerCenter 180, reports Buying-a-Mac.

Compu.D http://www.compu-d.com/spec.html lists the lowest prices we've seen on several of the Apple PowerBook 3400-series. These are the same low prices cited in Absolute Mac http://www.absolutemac.com/US/PRIX/prix.html and PowerPricing http://www.digiserve.com/buying-a-mac/powerpricing/. Unfortunately, Compu.D is out of stock on each. If Compu.D won't sell at these prices

when stock becomes available, please let us know. Add 3% for credit cards.

MacFixIt reminded us of Hayes' 56k upgrade http://www.hayes.com/56k/upgrade/offer: any old modem to a new Hayes 56k for \$99 plus \$15 shipping. This offer expires June 30.

As of today (4/1-97), you cannot buy a Zip drive at \$199 and get \$50 back. MacNN http://www.macnn.com/ reports that Iomega has reduced the minimum advertised price of its Zip drive to \$149 from \$199. Details can be found in a BusinessWire http://www.businesswire.com/cgibin/headline.sh?335592 article. This price drop offsets the \$50 factory rebate, which expired (3/31-97). If you bought a Zip drive before today, you're still eligible for Iomega's rebate as long as Iomega receives it (and a dated sales receipt) before April 15. So, if someone tries to

charge you \$199 for a Zip today, laugh heartily ... and hang up. An April Fool's joke? Recent prices from LACC http://www.lacc.com/

LA Computer Center's recent ads in the backs of MacUser and Macworld list, by far, the lowest prices to be found on the new Apple Power Macintosh systems. They're false. When a reader alerted us to them, we called LACC to verify these prices and found none to be accurate.

Actual prices undercut MacWarehouse's http://www. warehouse.com/ catalog prices by \$50, \$200, \$100, and \$100 respectively. Given LACC's 3% credit card surcharge, that's almost no savings at all. In fact, LACC charges \$8 more than MacWarehouse for the 9600/200 when adjusting for cash discounting. We understand that print ads can be inaccurate because they must be submitted two months in advance. But these prices are so grossly off, we can't help but wonder how they could pass through LACC's top brass. An LACC salesman explained that the salespersons at LACC don't know either. "I've been here for three years and we've never had an ad like that," he said. "Everyone's mad about it. It's a nightmare for everybody."

MacInTouch http://www. macintouch.com/ notes that Apple PowerMac 8600/200 systems are systems unavailable. An Apple spokeswoman told MacInTouch, "The 8600/200 has not yet shipped. Apple will have more information about the 8600/200 schedule late this week or early next week."

Buying a Mac has introduced PowerPricing http://www.digiserve.com/buying-a-mac/powerpricing/ a promis-

ing PowerBook price tracking service. It has attractive features, including pricing by vendor, entry dates, and notes on credit card surcharges.

Softclub http://www.softclub.com/apple.html has the PowerBook 1400cs/117 16/750/6x for \$2,365. Softclub also has the PowerMac 7300/200 32/2.0/12x in stock for \$2,575. These prices are cash-discounted.



## Online Army Knife™ (OAK)

#### **An Integrated Toolkit For Macintosh Users**

Submitted by Pamela Lienke

Online Army Knife™ (OAK), an integrated toolkit for Macintosh users, lives up to its advertising claims. Perhaps the most mentioned feature in the documentation and the direct mail advertisement is the pop-up spelling checker. It is incredibly fast (8,000 words per second on an 80 Mhz Power Mac 7100) and pops up anywhere to be used with all standard Macintosh applications. The user has the opportunity to have real-time spell checking or to batch process the document. When engaged in real-time spell checking, OAK notifies you of a misspelled word with a user defined alert sound or a flash in the menu bar. It then begins searching for the correct spelling and usually lists thirty to fifty suggestions by the time it completes its search, continuing to search for words while you type. OAK will even look up a phonetic spelling. If you type "sikietryzd," for example, it comes up with a suggestion. Most spell checkers simply identify that as a questionable word. The attached screen shot displays the results. OAK learns words that you want added to the dictionary. OAK



checks for transposed letters in many words. If you type "hte" OAK automatically corrects the spelling to "the" and indicates the changes with an alert sound or a flash in the menu bar. The separate glossary allows you to create shortcuts that expand to something else when entered. For example, if you

type "dd" followed by a space, OAK automatically inserts the date. You can define shortcuts for frequently used words, phrases, etc.

The Grammar Scan searches for troublesome words or punctuation errors as defined in the Grammar dictionary. Many of these are homonyms, although the grammar scanner also checks for double words and spacing errors. The default for spacing after periods is one space. If you can't break the "two spaces after

a period" habit that you learned back in tenth grade typing, you can change the default. If you accidentally neglected to capitalize the first word of a sentence, OAK flags that for you, too. The grammar scanner also notifies you if you have put too many



spaces between words. OAK displays problems in context as shown in the screen shot.

Another feature is MemoEdit, a text editor that serves as a replacement for SimpleText but that has features not available in SimpleText. Some MemoEdit window menu buttons change font, font size, and font color. Other buttons enable the user to check spelling and grammar; view and edit text; find and replace text; encrypt and decrypt text; and convert text to Internet compliant format using Net Converter. With a mouse click, you can change special Macintosh characters to generic characters acceptable in Internet documents: curly quotes change to plain quotes, the superscript trade-



## **New Format For Apple Software Downloads**

Over the next few weeks, we will be introducing exciting improvements to Apple Software Updates.

The all-new Disk Copy 6.1 provides the technology to make software downloading and installation easier than it has ever been before. Disk Copy 6.1 is required to take advantage of the new changes. Download Disk Copy 6.1 today to be ready for the changes to Apple Software Updates!

#### **New Packaging for Easier Installation**

Nearly all self-extracting archives (".sea" files) on Apple Software
Updates will be converted to a new format that will make downloading software updates faster and easier.
This format is called New Disk Image Format, or NDIF.

Disk Images in NDIF format are compressed to save space and download time, and decompress transparently at lightening speed when they are in use. Now you can access software instantly with just a double-click with no more leftover self-extracting archives. You can even mount and install software directly from NDIF disk images on the desk-

top instead of making floppy disks. If that was not easy enough, you can even automate software installation by the use of scripts. The NDIF format also includes checksums which guarantee the data integrity of disk images.

#### How Will this Work?

The existing disk image format requires the following steps:

Download and decode the .hqx (BinHex) file (or files), which results in a .sea file. Most Web browsers use Stuffit Expander to decode; most FTP clients decode on the fly. Double-click the .sea file to launch it and decompress the enclosed disk image. Throw away the .sea file. Make a floppy from the disk image. Insert the floppy and run the Installer, which will ask you to insert any other floppies that are part of the installation.

## The new NDIF format will require the following steps:

Download and decode the .hqx (BinHex) file (or files), which results in a Disk Copy NDIF disk image. Double-click on the disk image to mount it on the desktop. Run the Installer.

Optionally, you can also use DiskScript files:

Download the DiskScript file and place it in the same folder as the disk images that are part of the installation. Double-click on the DiskScript file. Disk Copy will automatically mount all the disk images that are

part of an installation and run the Installer. When the Installer quits, all the disk images will unmount.

#### Disk Copy 6.1

Disk Copy 6.1 is a completely overhauled and updated version of Apple's disk image utility. It is required to use the new NDIF format disk images. Disk Copy 6.1 offers the following features:

Make exact copies of floppy disks. Mount disk images on your desktop instead of creating floppy disks. Convert disk images from one format to another. Create your own disk images of any mounted volume. Create your own disk images of any folder. Supports NDIF disk images, existing disk image formats, and PC drive container files. Can be used to create your own compressed disk image files to save space on your hard drive. Can be used to archive your floppy disk collection. Completely supports AppleScript for easy automation.

Disk Copy 6.1 supports all 680x0-based Mac OS computers running System 7.0.1 or later, and it offers enhanced performance when used on PowerPC-based Mac OS computers.

#### Disk Copy 6.1.2 Quick Reference

Disk Copy 6.1.2 is a utility application that will mount disk images on your desktop, make exact copies of floppy disks from a disk image, convert disk images from one format to another, and create a disk image from a mounted volume or individual folder. Using DiskScripts and AppleScript, it can be used to automate software installations and disk image manipulation.

This Quick Reference will explain the basic functions of Disk Copy 6.1.2. More detail is provided in the Disk Copy 6.1.2 Manual and Balloon Help.

#### Changes from Disk Copy 6.1.

- AppleShare 5.0 support: Disk Copy can now mount images directly from an AppleShare 5.0 server, over an AppleTalk or TCP/IP connection.
- The Mount Image and Convert Image commands now include a "Skip" button during checksum verification.
- If Disk Copy 6.1.2 is in the foreground and a disk (floppy, CD, etc.) is inserted, the Create Image from Disk command will automatically start.
- Disk Copy can image non-mountable disks.
- Improved support for Macintosh Application Environment.
- Corrected some AppleScript recording anomalies.
- Various interface improvements.
- Corrected issue with mounting certain Disk Copy 4.2 format 800K images.

## System requirements and supported features

Disk Copy 6.1.2 requires System Software 7.0.1 or later and is a "fat binary" for both PowerPC and 68K-based Mac OS compatible comput-

ers. Macintosh Application Environment 3.0 Update 4 or later is also supported; A/UX is not supported. Disk Copy 6.1.2 features extensive Balloon Help and supports Drag and Drop (requires System Software 7.5 or later), AppleScript, PlainTalk Text-to-Speech, and DigiSign digital signatures.

#### **Disk Image Formats**

Disk Copy 6.1.2 can read and write three types of NDIF (New Disk Image Format) disk images (Read/Write, Read-Only, and Read-Only Compressed), Disk Copy 4.2 disk images, as well as read other disk image formats.

#### Mounting disk images

- Select one or more disk images and double-click. This only works for NDIF images (Read/Write, Read-Only, and Read-Only Compressed).
- Select one or more disk images and drag into the Disk Copy 6.1.2 main window (requires System Software 7.5 or later).
- Select one or more disk images and drag onto the Disk Copy 6.1.2 application icon.
- Choose "Mount Image..." from the Image menu and select a disk image.

After a disk image is selected, Disk Copy 6.1.2 will present a progress dialog for mounting and checksum verification (if the option is selected), and an icon for the mounted volume will appear on the desktop.

You can now work with the mounted volume as you would any regular volume. To unmount, either drag the icon to the Trash or select the icon and use the "Put Away" command from the File menu. When you restart you computer, any mounted disk images will be unmounted.

#### Making floppies from disk images

 Select one or more disk images and double-click while pressing the

- Option key. This only works for NDIF images (Read/Write, Read-Only, and Read-Only Compressed).
- Select one or more disk images and drag into the Disk Copy 6.1.2 main window while pressing the Option key (requires System Software 7.5 or later).
- Select one or more disk images and drag onto the Disk Copy 6.1.2 application icon while pressing the Option key.
- Choose "Make a Floppy..." from the Utilities menu and select a disk image.

Disk Copy 6.1.2 requires PC Exchange to make floppies from disk images that contain DOS or ProDOS volumes, such as a PC drive container or a DOS-formatted floppy. To make DMF (a 1.7 MB PC format) floppies, Disk Copy 6.1.2 requires a SuperDrive and Mac OS 7.6 or later, which includes PC Exchange version 2.1.1 or later.

After a disk image is selected, Disk Copy 6.1.2 will present a progress dialog for checksum verification and ask you for a floppy that is the same size as the disk image. You cannot, for example, use a 1.4 MB floppy to make an 800K volume.

When making floppies, Disk Copy 6.1.2 uses more memory that its default memory setting. If there is not free RAM available, Disk Copy 6.1.2 will not be able to make the floppy and will present an error message. Either quit other running applications or increase Disk Copy's Preferred memory size to 2048K.

If you insert a floppy that has been previously formatted and the Confirm Erases option is selected in the Preferences dialog box, Disk Copy 6.1.2 presents a dialog box asking you to confirm before erasing the floppy and copying new data to it.

#### Creating disk images

 Select one or more folders or disks and drag into the Disk Copy 6.1.2 main window (requires System Software 7.5 or later). Each folder

- and disk will be made into a separate disk image.
- Select one or more folders or disks and drag onto the Disk Copy 6.1.2 application icon. Each folder and disk will be made into a separate disk image.
- Choose "Create Image from Folder..." from the Image menu and select a folder.
- Choose "Create Image from Disk..." from the Image menu and select a disk.
- Bring Disk Copy 6.1.2 to the foreground and insert a disk.

After a folder or disk is selected, Disk Copy 6.1.2 will present a save dialog. Here you can enter a name and choose a format and size for the new disk image.

#### Converting disk images

- Select one or more disk images and double-click while pressing the Command key. This only works for NDIF images (Read/Write, Read-Only, and Read-Only Compressed).
- Select one or more disk images and drag into the Disk Copy 6.1.2 main window while pressing the Command key (requires System Software 7.5 or later).
- Select one or more disk images and drag onto the Disk Copy 6.1.2 application icon while pressing the Command key.
- Choose "Convert Image..." from the Image menu and select a disk image.

After a disk image is selected, you will see the same standard dialog box that is presented when creating a new disk image. Conversion is actually creating a new image based on the original.

Disk Copy 6.1.2 will then create a new disk image based on the selected original and save it using the size and format options.

#### About the Disk Copy log

The Disk Copy log window keeps a detailed record of all activity since the Disk Copy 6.1.2 application was launched. To view the log window, choose "Show Log Window" from the Edit menu. The contents of the log window can be saved to the "Disk Copy Log" file by selecting the "Save Log" option in the Preferences dialog box. The "Disk Copy Log" is a text file that is stored in the System Folder Preferences folder.

#### **Executing a DiskScript**

A DiskScript is a special file containing commands that instruct Disk Copy 6.1.2 to perform an action on a list of disk images, and to optionally launch an application with or without a specific document. DiskScripts are not related to, and do not require AppleScript to run.

- Select one or more DiskScripts and double-click.
- Select one or more DiskScripts and drag into the Disk Copy 6.1.2 main window (requires System Software

- 7.5 or later).
- Select one or more DiskScripts and drag onto the Disk Copy 6.1.2 application icon.
- Choose "Execute DiskScript..." from the File menu and select a DiskScript.

#### AppleScript support

Disk Copy 6.1.2 is fully scriptable, recordable, and attachable. To get a list of the scripting commands available, use a script editor application to view the AppleScript dictionary of Disk Copy 6.1.2.

Pentium processor; and the Power Macintosh 4400/200, with a 200MHz PowerPC 603e RISC processor and a Cyrix PR166 6x86 processor. These solutions are primarily targeted to business and education customers who want the power and ease-of-use of a Macintosh computer but also need Windows compatibility. The 166 MHz Intel Pentium processor PCI card is also available as an upgrade card, allowing PCI-based Power Macintosh computers to run

MS-DOS and Windows applications.

"Many of our business and education customers need to be compatible with the Windows operating system, but they will not sacrifice the ease of use and power of the Macintosh," said Phil Schiller, Apple's vice president of Product Marketing, Desktops, and Servers. "With these PC-compatible Macintosh systems, our customers can buy a Macintosh to do all of their critical work, and easily interact

with the Windows environment as needed."

Because the PowerPC processors in the new PC Compatible 7300/180 and 4400/200 Power Macintosh systems work independently from the Pentium or Cyrix processors on the 12" PC Compatibility Cards, customers can run Macintosh and DOS/Windows applications concurrently and instantly switch between Mac OS and DOS/Windows environments. Data can also be cut and pasted between environments. In addition to standard Macintosh networking capabilities, Power Macintosh systems installed with the PC Compatibility Card support MS-DOS and Windows networking applications and services using Novell NetWare IPX/SPX, TCP/IP, and NET-BEUI protocols over the built-in Ethernet network connection. The cards provide fast multimedia and application performance through the high-resolution accelerated graphics ATI Video as well as on-board Sound Blaster 16 support for high-fidelity audio output.

 Computers with "32-bit clean" 68030 microprocessors. All computers with 68030 microprocessors are 32-bit clean except the Macintosh SE/30, Macintosh IIx, and the Macintosh IIcx.

In addition, to install Mac OS 7.6, a computer must have at least 8 MB of RAM (random-access memory). If your computer has less than 16 MB of built-in RAM, you must use virtual memory. (Mac OS 7.6 automatically turns on virtual memory when you

install it.)

To install the recommended software, you need about 70 MB of free space on your hard disk. To install all the optional components, you may need up to 120 MB of disk space; if you install just the minimum set of system software, you may only need 40 MB. The exact amount of space needed varies for different computer models and hard disk sizes.

## Adult Reasons Why Educators Should Continue to Embrace Macintosh

Over the last three years my two co-authors and I have evaluated all the educational technology projects funded by an educational foundation in the 14 Western states. After visiting scores of schools and universities, corresponding with hundreds of teachers and administrators, and producing two videos, we concluded that the battle over which platform, Macintosh vs. DOS/Windows, was an adult issue.

Students easily adapt and move from one platform to another rather seamlessly. Students do get very upset when the platform they are given is incapable of doing some of the things they learn that another machine can do or do with less effort. But for the most part, kids adapt. So it is the adults who seem to have so much invested in the platform war.

The platform controversy often goes to extremes in school districts as allegiances are strong and bias is at times an insurmountable obstacle as it is in any holy war. People's emotional attachments to the platform they learned on often make it nearly impossible to be objective. This battle has left most educators, administrators, and board members at an extreme disadvantage in that they do not have an educational technology background and have had to rely on their technical computer support staff and others for information and recommendations.

The recommendations and infor-

mation they have gotten has often been biased by the platform bias of their techies. In the past educators, administrators, and boards may have been uncomfortable with this situation, but left it up to the techies. That situation has changed! The importance of the platform decision has become much more critical in the last two years, however, as the world and school technology programs are changing at breakneck speed.

The pervasiveness of the Internet as a new viable vehicle for commerce and information is driving this technological revolution in education. School districts will spend 5 billion dollars in the next year on technology and higher education is spending even more. Everyone is thinking about, and the vast majority of districts are, wiring their buildings and installing networks. As the American Association of School Administrator reports, school world wide web site home pages grew exponentially from 134 to 2,850 in just 18 months, 1995 into 1996. The importance and the amount of money being expended on school technology are making board members and administrators very nervous about platform decisions.

The national bad press that Apple has received has also increased administrator and board member anxiety over the platform issue. Macintosh is THE major multimedia platform in education today, according to the latest report by Quality Educational Data. The bad press has

prompted some school administrators I know to ask themselves the question whether they should purchase fewer Macintoshes. Board members and administrators are also at a disadvantage in making that decision because they often lack, or are not given, factual information upon which to base that decision.

#### **An Objective Analysis**

Anyone reading an article that might favor one side or the other in the platform holy war is immediately cautious of which side of the battle line the author is writing from. I have done many platforms from CPM to Macintosh to Unix to Windows. I have favored Macintosh in schools for many practical reasons, but with all the furor over Apple's bad press, I purposefully set out to objectively research the issue with an open mind, willing to consider moving away from Macintosh, if the facts indicated that the world had changed and that would be an appropriate decision. As Deputy Superintendent for Instruction and Technology of a large suburban school district that has been purchased \$8 million dollars worth of computers in the last four years — I have to remain as objective as possible in this fast changing world of technology. There is just too much at stake to let previous bias cloud being able to see what is really happening. Following is what I found in my personal research into the platform issue in the last six months.

#### **Networking and Networking Support**

Installing networks in schools is growing at an exponential rate. According to QED (1996) school district networks have grown 600% in the last five years. The ease and cost of supporting a platform on local and wide area networks should be a significant factor in deciding which platform to purchase. Our district has an extensive intranet and Internet network. We have installed thousands of Macs and PCs on our network in the last two years. We have found a significant difference between Macs and Windows machines. This difference is easily seen in the directions on how to instal each platform. The Windows directions are 3 pages long, single spaced, and only our district windows techies and a few building level techies can do the Win-stall. The Ma directions are 1/2 page long, including a picture, and we have trained all our librarians how to install Macs on the network.

Although Windows95 has gotten significantly better, even our most devoted DOS-heads still call it plug and pray. We have analyzed the time that it takes our technical staff to install the Windows platform, especially on multimedia windows machines. Installing a Ma on the network takes 10-15 minutes: Windows 3.1 45 minutes to an hour and Windows95 it takes 45 as well, although a small percentage of Windows95 machines can be as short as 20 minutes, as long as Windows95 will find and identify the correct ethernet driver.

If there are any problems on a Windows install, building level techies, simply can't handle it. Supporting the Ma platform on networks is exponentially less expensive and perhaps more important, requires far less district level support.

This lack of technical support, especially at the building level, has been identified in Texas and nationally as the number one problem in equational computing. Just buying technology has proven to be a major challenge for most districts and get-

ting enough technical support positions seems completely off the horizon. The ease of installing and maintaining a platform becomes a real concern when technical resources are at such a premium. Computers can sit in closets or on desk tops as dark screened Cassandras foretelling the death of the school's educational technology program.

#### **Cost of Supporting the Platform**

In the fall of 1995 Gardner Group, the national computer consulting firm that provides services to corporate America and larger educational institutions, released an independent study that concluded that Macintosh was at least 25% cheaper to support than the Windows platform. This data matches our District's general experience with platform support, especially with the advent of networking as such an important computer function.

#### Ease of Use and How to Use it

Which is easier to use, Mac versus Windows, is another of those "nary the sides shall meet" issues in schools. So perhaps the opinion of the CEO of the company that makes the most popular computer processor for Windows machines might be viewed as being a little less biased. Andrew Grove, CEO of Intel in his 1996 book, Only the Paranoid Survive, says on page 58, "Windows wasn't even as good as the Mac, let alone the NEXT interface, and it wasn't seamlessly integrated with computers or applications." Our experience with the Mac platform bears this out as the MacOS takes much less time to learn and to start using effectively. Windows95 has made improvements but it still has a good distance to go to match the MacOS. We expend much less staff development resources to start a Mac platform classroom and teacher.

#### Cost of Support: Replicating Business's Technology Model Won't Work in Education

Another factor that parents in particular express at school PTO

meetings is, "Shouldn't we have the same computers in the classroom that are the majority in business?" This is also especially enticing for school administrators and board members who are much more in tune with business and business management practices. But there are some key differences between business and education, especially in regards to computing.

The first major difference is that studies show that business provides a support ratio of one computer support person for every 35-60 users. In our district the ratio is closer to one technical support person for every 750 users. National studies and a recent study in Texas, list computer support the most critical problem in educational computing at the district and particularly at the building level. Given how difficult it is to get money just for computers, hiring an army of techies to support them will not fly with tax-payers and parents. Business' computer support model would be nice for education, but it just won't happen.

The last, and perhaps most surprising reason that business computing is not a model for education is that K-12 students are power users. Most K-12 students use the computer as a true multimedia tool and their technological expertise is very sophisticated, especially when compared to most business users.

# We Have Students Who Construct Their Own Internet Web Pages — They Have No Front Teeth and They Still Believe In the Easter Bunny!

The vast majority of business people do not use the full multimedia capabilities of their computers. Elementary students in putting together a multimedia report will record sound, scan pictures and draw graphics, input a digital camera image, incorporate word processing, program an animation, and even input a video segment into their multimedia report. Few business users begin to be that sophisticated. Student computers have to have more capability and power. Putting a

standard business desk-top in every classroom would seriously hamper most of our student computer users.

#### What Computer Features Best Support and Enhance Learning: Multimedia

When the first computers hit classrooms in the late 1970s, we took the new technology and used it in our current way of doing things—we created Computer Assisted Instruction (CAI), Electronic workbooks. We have since learned that a workbook in paper form is only \$10 dollars while a computer costs, \$2,000. Moreover, we have found that multimedia enhances student learning in ways that are amazing that that we are just beginning to understand.

Regardless of the affects of multimedia learning that we are just starting to realize, the Internet has made it obvious that multimedia is the present and future of computing. The install base of multimedia machines in schools is now 1.9 million or 41% of the total. (QED, 1996) We have learned that computers are tools for learning and discovery and that information and knowledge and more than just the text and pictures we have had in books. Information is digitized and can be text, pictures, graphics, sound and video. Providing information in all these ways really enhances learning for all students and especially for all those students we know are very bright but have just not reached their potential in school. In addition, once kids use multimedia, they want to use it all in their learning. This generation of young people in our schools is creating a "time-bomb of computer users" as Andrew Groves discusses in Only The Paranoid Survive.

## Which Multimedia Platform Delivers the Most Capacity at the Best Price?

The very thing that has caused Macintosh its biggest challenge is the very thing that most benefits schools, a truly integrated system. Apple kept its operating system and didn't allow others to use in

machines made by other manufacturers. DOS/Windows thus gained market share in the business world because computers and parts became commodity items. You could mix and match and build your own in the PC world. This permitted endless variation. All PCs came with various slots that you could put different card devices in and have the computer that best met your needs. Every Mac, on the other hand, comes equipped as a full multimedia machine with sound input/output and graphics features. All the components in Macs were from the same design/manufacturer and therefore they all have been designed to work together.

This endless variation on the DOS/Windows side, however, has lead to many serious problems in different devices that were made by different manufacturers and installed in different slots in the PC. I have seen this problem cause havoc in many places, and in schools in particular, where advanced technical support is lacking. One project between several different school districts was delayed for over nine months because the PCs they had would not function with both the CD-ROM drive and the ethernet card installed.

Over the last year, even our district's most ardent Win-heads have been enthusiastic about purchasing Macintoshes, as Macintosh delivered far more RAM, hard-drive and full multimedia features than any Windows manufacturer at a far cheaper price. Some of the Windows manufacturers, such as Compaq are really starting to make headway in delivering comparable capacity at more comparable prices, but the slot addressing and driver problems continue to be a problem that is not going to go away in the near future. Our district analysis is that Apple is till delivering the fastest and most fully multimedia integrated machines on the educational market.

## Best Company Sales and Support to Education

Apple has the most sophisticated sales and support force for education. Some PC resellers are providing excellent service, but no PC manufacturer can provide the information, assistance, and support that Apple has been so good at developing over the last 20 years. In addition, the majority of Apple's educational support and sales personnel are former teachers themselves and have a good understanding of the needs of teachers and students and how technology enhances learning. The other manufacturers tend to hire business graduates who do not have the important experience and knowledge. Again, Compaq is making in-roads in this area by developing a functioning educational marketing team complete with former educators and former Apple employees... but it will be a while in developing.

## Conclusion: Macintosh is Still the Best Platform for Education

Our students do get very upset when they know that they can do things on the Mac that the Window machine can't or they can't get the Windows multimedia functions to work properly. But Kids are extremely adaptable and can use any platform or combination of platforms seamlessly. However, when I consider the strictly adult reasons for choosing a platform, money, resources, capabilities for learning, and fewer problems— Macintosh is still the best computer platform for education.

#### Will Apple Survive is Also An Issue: Chrysler Came Back - So Can Apple

But "which is better" is not the only issue in the platform debate. Many school districts and other educational institutions have questioned their continued purchase of Macintosh based on the possibility that Apple won't survive. The current media feeding frenzy and the Apple's dying spin they are putting on all stories about Apple have made

everyone wonder. I have wondered myself, but every time I get very far down that path, I think of four sales emaxeigracetixment aibeMi(A:anet pleg of stampede beliavior and they not are most often inaccurate perceptions of reality— I shouldn't believe everything I read or see on TV; 2) That Jobs, Wozniak, and Kawasaki are back involved in Apple and that will count for something; 3) Chrysler nearly went under and came back to lead their industry — so can Apple; 4) Thatriead competition provides a year Educations with the loss red ftware and hardware... and we need that competition to provide us with choices and better products.

Apple will probably still have more bad news in their struggle, but many of us sincerely believe that they will make it in the market place and remain! Education smost prolific platform. Compaq is right on their heals though in focusing on education and will provide some great competition. But that is the major point, education needs that competition real competition between hardware and platforms.

## Uncertainty in the Computer World in General: Who Knows Where It is Going!?

Another factor that has heightened anxiety over the Mac/Windows platform debate, is the general anxiety about the vast amount of uncertainty and risk there is in the computer world in general. The world of computing is about to (or at least most people anticipate that it will) go through several major metamorphoses. The fight over Win-tel's (Microsoft Windows and Intel) support for Windows NT on IBM and Motorola chips has technology directors wondering which way to go. The addition of the Apple/Next acquisition, Rhapsody, multi-platform operating system, and what advances it will bring to the desktop.

The techno-world seems even more disconcerting by the battle between the use of thin clients/client server desk-top networks versus the full blown multimedia machines with "bloatware," large programs requiring big operating and storage memory. The introduction of radically new products especially

designed for Education, such as, Apple's new E-Mate 300 portable for students adds to the mix of questions about what to buy. All this uncertainty has left many educators very nervous about computing in general. It is all moving so fast and any decision you make could become a mistake. However, the best advise for how to make decisions in today's very uncertain world might be to go with adult reasons for making decisions: Which platform that exists right now saves the most money, time, and effort, and simultaneously, delivers the most features that educators and students need at the best price?

## HARD DRIVES AND THE APPLE ][

Why would anyone want to add a hard drive to their Apple ][ (A2)? First and foremost, we need to spite all those know-it-alls who say it can't be done. Tot snosser Thing.

If that is not enough having a hard drive makes you and your A2 more productive. You no longer have to fumble with floppy disks to get a program up and running. All of your programs are available at your finger tips; using a program selector such as Prosel or the Finder allows you to select from among your applications with just one or two key strokes. In addition; those program files load into memory and are available for use in a fraction of the time that it takes for files to load from a floppy.

As a bonus, a hard drive puts all your data files at your fingertips.

Instead of having a floppy disk (or

two or three) for each of the different data types, each data type is available from a subdirectory on that hard drive. Here, too, your files load into memory and are saved back to disk in a fraction of the time that is required with floppies.

You can't do away with floppies entirely because you still need to have back-up copies of your important files (You do keep multiple copies of your important files, don't you? If not, you're asking for a major disaster!). With the hard drive, however, you only need to put up with the floppy delays when you are backing up or restoring files.

There are two ways to add a hard drive to an A2e or an A2GS. A SCSI interface card enables your computer to talk to a hard drive (SCSI defines a method for computers and peripherals to exchange data over a parallel interface at a relatively high speed).

Apple brand SCSI interface cards are available on the used equipment market (Shreve Systems, swap meets, the Internet, and so forth). A revision C card will operate satisfactorily; a High Speed card is preferable if available. Sequential Systems sells the RAMFast SCSI card which outperforms the Apple cards and is still being supported but is probably a little more expensive than the Apple cards. Any SCSI drive will work with one of these SCSI cards. Older, smaller hard drives that Mac users no longer want can be found inexpensively. Forty megabyte drives will support an A2e quite nicely and eighty megabytes is nice to have if you have many applications or many graphics. Since a typical A2GS user keeps lots of sound and graphics files around, a hard drive of 200 megabytes or more capacity is useful. Note that multiple hard drives can

be connected to a SCSI card as long as the address of each drive is unique (switches are available on most drives to set the SCSI address). Once you have a SCSI card, you can also add CD-ROM players and ZIP drives to your system.

The second way to add a hard drive to a A2e or A2GS is to add a hard card: an IDE hard drive mounted directly on an interface card (IDE is a slower and less expensive interface widely used in the PC world). The FOCUS hard drives are available from Alltech Electronics. Available in sizes from 20 to 200 megabytes,

these drives simply plug into a slot in your computer and are ready to use. Special software comes with the drive to enable it to be reformatted if that should become necessary.

Which approach is better? The hard card provides a very convenient bundle but is not expandable. The SCSI card with external drives is expandable but may be more expensive. You have to decide for yourself.

You say you have an A2c or A2c+ and would like to make use of a hard drive. You can't add a card to your machine but there is a hard disk capability available. You may be able to locate Chinook hard drive systems on the used equipment market. These systems use the floppy disk interface to transfer data to and from the hard disk. The data transfer rate is not as high as with the //e and ][GS cards but still is better than the floppy disk rate. If you can't find a used system, Sequential Systems sells new systems in 40 and 100 megabyte models.

## **SCSI Tips**

Sometimes a SCSI interface acts like it's controlled by gremlins. Data is corrupted or disappears spontaneously. Here are some things you can do to help make your SCSI interface well behaved.

#### Use high quality cables.

Those \$7.95 cables you bought at Best Buy could cost you lots more in the long run. In general, fat is better than skinny and short is better than long. Fat cables usually have slightly larger wires that are spaced a little farther apart. Larger wires provide a lower resistance path for the SCSI signals; wires that are farther apart are better isolated. Both of these fac-

tors make the interface less noisy and more reliable. Keeping the cables as short as practical also minimizes the noise and increases reliability.

## Terminate the SCSI chain but at the last unit ONLY.

SCSI termination provides reference voltages that help the interface run reliably. The last drive on the SCSI chain must have an external terminator plug or must be terminated internally to maximize reliability. Terminating the SCSI chain in the middle or in more than one place reduces reliability. If you have a drive that can be terminated internally, make sure the termination capability is disabled when the drive

is not last on the chain.

#### Provide terminator power.

The Mac internal SCSI interface provides power that enables the terminators to do their job. Apple brand SCSI cards for the Apple 2 do not provide terminator power; either the cards must have diodes added or at least one of the drives must be configured to provide terminator power. The RAMFast SCSI card for the Apple 2 has a jumper which enables terminator power. No harm will come to any equipment if terminator power is provided by more than one unit.

# Master Juggler Pro 2.0 The Ultimate Font Management Utility

If you are a font junkie like me, it can be very frustrating watching your system groan under the weight of many fonts loading and displaying when clicking on "Font" in the menu bar. Sometimes it seems the display will reach halfway to China! Think of the RAM being used each time you do this.

Is there an easier way? You bet! If you attended the OACC Font Management workshop in October, you would have seen both Type Tamer(TM) and Master Juggler Pro(TM) in action.

Type Tamer controls the display of fonts, making access to active fonts, special characters, and font menu organization much easier.

Master Juggler Pro helps you organize your fonts by allowing you to store them on your hard drive. The only fonts that you must keep in your system folder are Geneva, Monaco and Chicago (these three are needed for certain system functions). There may be others loaded by certain applications, such as Lock Font, that you will want to leave there too. With Master Juggler, all others can be stored in folders on your hard drive.

I have several hundred postscript fonts (I never use True Type fonts except for the required system fonts, Geneva, Monaco and Chicago). About twenty of these Postscript fonts are "favorites" that I use all the time. With Master Juggler, I load these favorite fonts from the "available files" window of the MJ application to the "open files" window. They are then ready for use whenever my Mac is operating.

Many of my fonts are nested in a folder on my hard drive named "Bob's Fonts." (Others are in folders on my Syquest cartridges.) Inside "Bob's Fonts" folder I have simply created five folders named "Fonts A through B," "Fonts C through F," etc. Inside these folders I keep the alphabetically named suitcase for each font (containing the screen version) plus the outline font representing each screen version contained in a suitcase. (Note: Don't put the outline fonts inside the screen font suitcase!)

Master Juggler Pro 2.0 can now reside on the desktop as an application-a major change from prior versions. It also resides as an extension in your Apple menu. Whenever I need a particular font or fonts, I simply open MJ, select the fonts I want to use from MJ "available list," and add them to the "open list." With the new MJ Pro, you can now make non-contiguous font selections for adding or deleting by holding down the command key-a neat time saver!

By holding down the command key when opening a font from the "available menu," you will be opening the font as a "temporary" font. When you shut down your Mac, the "temporary" font will be automatically closed.

Or, you can drag and drop an

active folder of fonts onto a "MJ Drop Closer" alias and have the fonts closed for you. You can also open a folder of fonts the same way by dropping the folder onto an alias of the MJ application.

With MJ Pro, you can also create "sets" of fonts for use in specific applications. These sets act as a representation of the original font and take up virtually no space on your hard drive. If a font within a designated set is also open in your "available files," it is no problem. MJ has no conflict with this.

I particularly like the "Fonts Gathering" feature of MJ. If you're selecting fonts for a service bureau (or, any purpose), just select "Gather Fonts" from the MJ "special menu." Then, choose the fonts you want to gather, check the dialogue box if you want the outline fonts included (of course you do) and voila, you have a folder of fonts ready to go! Really slick! If you want to open this newly created folder of fonts, just drop it on the MJ application alias, and they're opened as "temporary" immediately.

MJ Pro's "Font Guardian" is great for finding font conflicts, missing outline fonts, duplicate fonts, etc. With MJ's option menu, you can set Font Guardian to run when you want it to. I found several problems with my fonts by running Font Guardian. I may never have found them otherwise. From the MJ Special menu, you can also use "Examine Suitcases" to check your fonts for conflicts or problems at any time.

Master Juggler Pro also gives you the ability to view your fonts in their

actual typefaces, compress and decompress your fonts to save hard drive space, and to create an empty suitcase right from the MJ Special Menu.

If this is not enough, Master Juggler Pro has some other cool features. From the Apple menu, you can an "Application List" available to you. Once opened, select command-A, You can then add your frequently used applications or documents to this list. You can also create a Hot Key for the application list that will bring the list to the desktop, allow-

ing you to select/open any of your application/documents, or to switch back and forth between them.

I also like MJ's "Hot Sounds" feature. It will let you select sounds from your System to play for events like "disk eject," "launch," "restart," and more.

The "Options" selection from the MJ Special Menu allows you to configure MJ's preferences just about any way that fits your operating needs.

The bottom line is... I think
