Apple Maintains Top Education Spot

CUPERTINO, California-November 1, 1999-Apple today confirmed that it holds the number one position in sales to the U.S. Education market as shown by recent data from leading Education market research firms, including Quality Education Data (QED) and International Data Corp. Mac OS 9; The Agony and the Ecstasy

My job Saturday morning was to install Mac OS 9 on a new DV iMac, an iBook, a Blue & White G3 and two Bronze PowerBooks. I had lots of "help." I was at the Mesa CompUSA store assisting with Apple Demo Days, and roll-out of the new operating system was prominently advertised. Customers looked on while the new System was being installed.

There are many new features in OS 9, and it's very tempting to rush into the upgrade. You can read about the new bells and whistles on the Apple Mac OS 9 page. Sherlock 2 is absolutely beautiful, and I want to play with the voice recognition feature that will let me speak to my Mac and unlock the machine.

I opted for a "clean" install (see my October 7 column for instructions) on the iMac. Everything went fine for the seven or so minutes it took for the Mac OS 9 installer CD to do its job. On restart, the DVD movie in the CD slot wouldn't play. I found that three DVD extensions had not been moved to the new System Folder. Moving them resolved the problem.

Next came the B&W G3. I'd been tipped off by Apple about a little problem that is explained in the installer Read Me, but it's buried way down in the document. I missed it when I read the text.

If you launch the installer, you get a message telling you that you must first run the G3 Firmware Updater. But the message doesn't tell you where to get the updater. Turns out it's hidden in the CD Extras folder on the installer CD. The updater will achieve improved PCI performance. You cannot run the OS 9 installer on a B&W G3 until you update the firmware.

Open the CD Extras folder on the Mac OS 9 installer and locate the "G3 Firmware Update" folder. Copy that folder to your hard drive. Read the "Read Me" in the folder. You will be instructed to:

- 1. Launch the installer.
- 2. Click the Shut Down button

that will appear.

- 3. There are two small buttons on the front of the computer beneath the power button. The right-hand button is the programmer's button (see the illustration in the Read Me).
- 4. Hold down the programmer's button and press the power button on the front of the computer or on the keyboard while continuing to hold down the programmer's button.
- 5. Release the programmer's button when you no longer hear a tone.
- 6. After your computer starts up, if the update was successful an unlabeled progress bar will appear. When the progress bar is full, a message will appear telling you the firmware is updated. Click OK.

Now, boot the computer with the installer CD and proceed with the installation of OS 9. Otherwise, installation on these five Macs were uneventful.

Incompatibilities and other glitches

As you may be aware, quite a bit of software needs to be updated to work with OS 9. This was not unexpected because OS 9 is a major upgrade.

My biggest concern was that Adobe Type Manager and Adobe Type Reunion must be updated. My work requires lots of fonts, and I use ATM and ATR to manage them, as many others do.

Friday, on the eve of the release of OS 9, Adobe came through with updaters. These, and other updaters plus a report on conflict and incompatibility problems, are listed in the very comprehensive Troubleshooting Mac OS 9 MacFixIt Report. The report is updated daily, except on weekends.

You might also want to visit the MacFixIt Troubleshooting Mac OS 9 Forum where you'll find a great deal of useful information.

Another good source for information about OS 9 updaters is Version Tracker.

One reason software publishers must update their software is Apple improvements in the File Manager portion of the new operating system. Alsoft has posted a very helpful utility, Mac OS 9 File Manager Compatibility Checker, on its Ask Al page.

Should you update now?

In my October 18 column, I suggested you wait a while before upgrading to OS 9. Now that I've had some experience with the new operating system, I'd advise you to go ahead and update after you've read the information in the links above and resolved any compatibility problems that affect your Mac.

Do you have enough RAM to update?

In addition to software update problems, the Mac operating system RAM requirement continues to spiral upward with the release of OS 9. The new system uses 24MB of RAM with no third-party extensions or hardware installed. I have not installed the new OS on a Mac with less than 64MB of RAM, and I assume that the installation on a RAM-challenged Mac will set Virtual Memory to 64MB or more.

Using VM, or RAM Doubler, would enable such a Mac to use OS 9, but the real (and possibly expensive) solution is to install more RAM. The new iBook, for instance, ships with a meager 32MB. It would be a cruel joke to dump OS 9 into someone's iBook without cautioning them about the performance burden that the use of Virtual Memory will impose. And RAM Doubler is not compatible with OS 9. A report says Connectix doesn't expect to have a RAM Doubler update available until January.

Is your new keyboard missing something?

The Mac keyboards shipped with the iMac, B&W G3, G4, the newer PowerBooks and the iBook are missing some keys. John V. Holder Software (John is one of my favorite software authors), has released KeySwapper, \$5 shareware. The blurb says, "KeySwapper will allow you to use any key(s) you like to emulate other keys that your computer may not have (such as the Forward Delete key, the Page Up key, the End key, function keys F13 - F15, etc.)! You can

also disable the Caps Lock key if you wish."

It works.

Every once in a while I go to http://www.tucows.com and check out what new software is available for download. This time I came across NetFinder, which fills a niche I noticed back when System 7.5 came out and which I've been expecting Apple to build into the OS ever since. Maybe now that somebody's written it, Apple can build it into Mac OS 9.5 or X.

NetFinder allows you to connect to any FTP or HTTP site and work with it as if it were an AppleShare server... which is to say, the files appear in ordinary Finder windows, and you work with them just like you Firewire ports on these systems are compatible with Digital Origin software. All other G4 models, known as 'Sawtooth', use new FireWire hardware (OHCI) and are not compatible with Apple's Firewire 2.1 drivers. Digital Origin is working with Apple to resolve this compatibility problem and we plan to release a downloadable updater in the future. Until then, the G4 Sawtooth models must use the Digital Origin 1394 FireWire card.

How can you tell the difference between the two G4 architectures? All the compatible G4 models also use a PCI graphics card. Models with the incompatible OHCI Firewire use an AGP graphics card. Refer to Apple's

would in the Finder. However, if you don't specify the password when you create the alias, you'll be asked for it when you try to connect, which is fine. It will also work with Mac OS 9's keyring feature for secure password storage.
