Miniapples Directors Meeting August 1, 2005

Present:: Les Anderson, Craig Arko, Jim Nye, Don Walz, Bert Persson, member Brian Bantz.

Approval of Agenda: Agenda approved with several additions.

Approval of Minutes: July 11, 2005 minutes approved.

Treasurers Report- All bills for the months paid except a bill received on August 1. A letter will be sent to Brian Bantz & Dave Lundeen acknowledging our receipt of money from the Naugsaw account. The letter will officially close out the account and no future action will be necessary.

OFFICERS AND CO-ORDINATORS REPORTS

President Gates- Unable to attend meeting because of prior business.
Vice President Persson: Vice President Persson conducted the meeting in President Gates absence. The group discussed sending newsletters to libraries as a way to get the word out about the club. Motion made to send the newsletter out to area libraries, seconded, passed.
Secretary Nye: A friend of his son, who is a long time Apple user and is going to school & working in Eau Claire Wisconsin, showed some interest in being a SIG leader. Because of

working, going to school and the distance from the Twin Cities he would probably be available only about every 2-3 months. He expressed interest in attending one of our SIG meetings.

SIG Director Arko; The Photoshop meeting appears to be an Adobe event. The club will cooperate with the group and run meeting notices for members who wish to attend. Director Arko met with Celeste Holms and Dave Shaw who will contact libraries for a site to hold the Main Mac meetings. Director Arko also floated the idea to combine the Q&A (novice) and Main Mac meeting together.

Director at Large Anderson- The August newsletter was mailed out and some duplicates were also mailed to get up to the 200 minimum bulk rate requirement. Presently, the mail account is in good shape with a balance of \$300. It is expected that about a dozen people will drop out after the June membership is tallied.

OLD BUSINESS

The club has not been able to contact Tami Brass who inquired earlier about starting a user group for her students at Oakland Jr. High, Lake Elmo- Stillwater School District. Craig Arko will follow up and try to contact her.

NEW BUSINESS

Newsletter -The Board discussed putting the newsletter on the web. Craig Arko suggested publishing a portion of the newsletter coverage on the web because the younger computer users seem to prefer electronic rather than printed copies. The discussion ended with talking about the option of having both a printed & electronic copy of the newsletter. Photoshop SIG or meeting- Craig Arko will contact Adobe and inquire about the direction the meeting is taking.

Workshop- A site is being searched for the workshop, which will be held at the end of October or 1st week in November.

Auction- Group discussed possible tentative dates for the auction citing the end of November or first part of December as possible times to hold the event.

Club Records; Brian Bantz appeared before the Board to inquire about past club records. Brian was looking for old records for business purposes. He was told the club does not archive records, but Bert Persson informed Brian that he has copies of old newsletters if that would help him. The club will submit a letter for Mr Bantz noting his club affiliation if that would be useful to him.

Therefore we like to restrict our auction to computers capable of running system X (OSX) or later using USB ports or newer I/O architecture. This will limit us to accepting beige G3 machines, iMac's, iBooks or newer, B/W G3, G4 etc. Printers and scanners would have to be USB capable. Since monitors pose a hazardous waste problem, we like to have them only if they are part of a complete system.

In conclusion, we would like to make this years auction an event were people who are not on the "bleeding edge" of technology an opportunity to use the newer Apple operating systems and software.





Lowercase Times Keyboard



Hold down the Shift & Option Keys for these Times characters



Lowercase Webdings Keyboard




Uppercase Webdings Keyboard





Hold down the Shift & Option Keys for these Webdings characters




Lowercase Zapf Dingbats Keyboard




Uppercase Zapf Dingbats Keyboard


