Welcome to the "Apple // Forever" Expo and Dealer Conference.



Registration/Hospitality Desk

Registration begins on Monday, April 23, at each of the conference hotels from 4:00 P.M. to 9:00 P.M. You must register at the hotel where you are staying. Attendees not staying at one of the conference hotels can pick up their registration materials Monday, April 23, *ONLY* at the St. Francis Hotel. Persons arriving after 9:00 P.M. on Monday can register at Moscone Center beginning at 7:00 A.M. on Tuesday, April 24.

When you register, you will be issued a name badge. This badge must be worn for all events, beginning with the Dealer Welcome Reception on Monday evening at the St. Francis Hotel.

An Apple Hospitality Desk will be located at each of the conference hotels and at Moscone Center during the entire "Apple // Forever" event. Travel Incentives' staff will be available at each of these locations should you have any questions regarding accommodations or travel.

Transportation

Apple has arranged for shuttle service between the conference hotels and Moscone Center for the "Apple // Forever" event. On Monday, April 23, shuttle service will operate between the Hyatt Regency Embarcadero, the Meridien, and the St. Francis hotels. These shuttles will operate between 1:00 P.M. and 9:00 P.M. Please note that the Hyatt Union Square is within walking distance of the St. Francis Hotel where the Dealer Welcome Reception will be held.

On Tuesday, April 24, shuttle service will begin at 7:00 A.M. from all conference hotels to the Moscone Center. Shuttles will run continually throughout the day, to and from all events at Moscone Center.
